AS THE GERMAN PERMREP SAID, "THE GOVERNING COUNCIL PROVIDES THE INTERNATIONAL COMMUNITY WITH AN IRAQI PARTNER WITH WHOM WE CAN ENGAGE." A THEME COMMON TO ALL SPEAKERS -- INCLUDING SYG ANNAN, SRSG DE MELLO, GC LEADER PACHACHI, AND NEARLY ALL SC MEMBERS -- WAS RECOGNITION OF THE GC AS AN "IMPORTANT FIRST STEP" ON THE ROAD TO RESTORING IRAQI SOVEREIGNTY.

2. (U) DE MELLO AND PACHACHI BOTH LAUDED THE FLEXIBILITY OF UNSCR 1483; DE MELLO SAID THE RESOLUTION'S "LATITUDE" WILL ALLOW THE UN ROLE IN <</RAQ>> "TO EMERGE AND DEVELOP AS THE

SITUATION ON THE GROUND DEVELOPS." SIGNIFICANTLY, HE SAID: "WHAT THE UNITED NATIONS CANNOT DO IS REPLACE THE COALITION PROVISIONAL AUTHORITY (CPA).... WHAT THE UNITED NATIONS CAN DO IS TO HELP FACILITATE AND BUILD CONSENSUS AMONG IRAQIS, AND BETWEEN IRAQIS AND THE CPA." FRANCE AND GERMANY BOTH EXPRESSED SUPPORT FOR A NEW RESOLUTION AWARDING THE UN A LARGER ROLE IN <<IRAQ>>. THE RUSSIAN DPR ALSO EXPRESSED SUPPORT FOR "SUPPLEMENTING" THE UN ROLE. 3. (U) AMBASSADOR NEGROPONTE STRESSED THE IMPORTANCE OF THE ESTABLISHMENT OF THE NEW IRAQI GOVERNING COUNCIL, PER REF B INSTRUCTIONS. FOR THE FIRST TIME IN DECADES, THE IRAQI PEOPLE HAD A REPRESENTATIVE POLITICAL BODY. "THE GOVERNING COUNCIL WOULD PLAY A LEADING ROLE IN DETERMINING THE PROCESS FOR DRAWING UP A NEW CONSTITUTION AND PROCEEDING TO DEMOCRATIC NATIONAL ELECTIONS." THIS BODY, HE EMPHASIZED, DESERVED THE FULL SUPPORT OF THE INTERNATIONAL COMMUNITY AND THE SECURITY COUNCIL. HE URGED THE INTERNATIONAL COMMUNITY TO CONTRIBUTE TO THE STABILITY FORCES IN <<IRAQ>>, AS CALLED FOR UNDER OPERATIVE PARAGRAPH ONE OF UNSCR 1483. 4. (U) SYG ANNAN WELCOMED THE GOVERNING COUNCIL (GC), AND LISTED SEVERAL FUNDAMENTAL PRINCIPLES UNDERLYING UN INVOLVEMENT IN <</RAQ>>.

-- RESPECT POLITICAL FUTURE OF <<IRAQ>>; -- IRAQI SOVEREIGNTY OVER TERRITORY AND NATURAL RESOURCES; -- RESTORE <<IRAQ>>'S POSITION IN THE INTERNATIONAL COMMUNITY AS A COUNTRY AT PEACE WITH NEIGHBORS.

SPECIAL REPRESENTATIVE FOR <<IRAQ>> SERGIO VIEIRA DE MELLO HAD DONE PRECISELY THAT. OUR COLLECTIVE GOAL WAS THE FORMATION OF AN INTERNATIONALLY RECOGNIZED IRAQI GOVERNMENT. 6. (U) THE UN WOULD WORK WITH THE GC TO OUTLINE AREAS WHERE UN MIGHT BE OF ASSISTANCE. THE GC LEADERS SHOULD BE RECOGNIZED FOR THEIR STATESMANSHIP FOR ASSUMING THIS RESPONSIBILITY. AS THE SYG NOTED IN HIS REPORT, THE DAY WHEN IRAQIS MUST GOVERN THEMSELVES MUST COME QUICKLY. IN THIS REGARD, <<IRAQ>> NEEDED THE SUPPORT OF NEIGHBORS TO EMBRACE THE GC AND PROVIDE IT WITH WHATEVER ASSISTANCE IT REQUESTED. -- DRAWING UP A CONSTITUTION (ESSENTIAL THAT THIS WAS AN IRAOI PROCESS AND AN EARLY FOCUS OF GC DELIBERATIONS) -- TIMING AND PRECISE NATURE OF ELECTIONS (FOR AN INTERNATIONALLY RECOGNIZED GOVERNMENT TO BE ELECTED)

THE ELECTION PROCESS COULD NOT BEGIN TOO SOON -- IT WAS A SIGNAL OF THE INTENT THAT FULL SOVEREIGNTY WOULD BE RETURNED TO <<IRAQ>>. A CLEAR TIMETABLE WITH MILESTONES FOR IRAQI SOVEREIGNTY WOULD HAVE TO BE OUTLINED AS SOON AS POSSIBLE, SO THE IRAQI PEOPLE KNOW "THAT STABILITY WILL RETURN AND THAT THE OCCUPATION WILL END." THE SECRETARIAT'S ELECTORAL ASSISTANCE DIVISION WOULD SOON VISIT <<IRAQ>> TO DISCUSS AND ELECTORAL FRAMEWORK WITH THE GC AND THE CPA.

LAW AND ORDER

7. (U) THE CPA HAD THE PRIMARY RESPONSIBILITY FOR MAINTAINING SECURITY, LAW AND ORDER. THE GC, HOWEVER, NOW ALSO HAD RESPONSIBILITIES WITH REGARD TO NATIONAL SECURITY, AND ULTIMATELY ONLY IRAOIS COULD PERFORM THIS RESPONSIBILITY. THE UN HAD CONSIDERABLE EXPERTISE IN THE AREA OF NATIONAL LAW AND ORDER CAPACITY, AND THE CPA AND GC SHOULD TAKE ADVANTAGE OF ALL UN ASSISTANCE IN THIS AREA AS WELL AS BILATERAL OFFERS OF ASSISTANCE IN POLICE DEVELOPMENT. ON HUMANITARIAN ASSISTANCE, EMERGENCY REHABILITATION AND HEALTH AND DE-MINING REQUIRE ADDITIONAL URGENT SUPPORT. THE UN SHOULD BE ABLE TO HAND OVER THE OIL-FOR-FOOD PROGRAM IN A SMOOTH MANNER IF

THERE ARE COORDINATED EFFORTS ON ALL SIDES. THE NUMBER OF CONTRACTS BEING ADOPTED, HOWEVER, IS MUCH LARGER THAN IMAGINED BECAUSE THE REHABILITATION PROCESS BEGAN MUCH SOONER THAN ANTICIPATED. IN THE NORTHERN GOVERNORATES, THE CPA HAD SUGGESTED THAT THE HAND-OVER TAKE PLACE TO IRAQI AUTHORITIES AT BOTH THE REGIONAL AND CENTRAL LEVELS; THE UN WAS WORKING ON A STRATEGY TO PRESENT TO THE GC AND THE CPA.

HUMAN RIGHTS

8. (U) THE IRAQI PEOPLE WOULD HAVE TO DEAL WITH THE PAST CRIMES COMMITTED BY THE FORMER REGIME. THERE WAS "MUCH MERIT" IN CONSIDERING THE ESTABLISHMENT OF A MIXED IRAQI AND INTERNATIONAL PANEL OF EXPERTS TO CONTEMPLATE THE BEST OPTIONS FOR DEALING WITH THESE SERIOUS CRIMES. THE UN WOULD CONTINUE TO FACILITATE DISCUSSION ON THIS ISSUE, WELCOMING A VISIT BY UN SPECIAL RAPPORTEUR FOR HUMAN RIGHTS IN << IRAQ>> ANDREAS MAVROMMATIS. THE CPA HAS BEEN RECEPTIVE TO CONCERNS REGARDING THE SEARCHES, ARRESTS, <<TREATMENT>> OF <<DETAINEES>> AND

10. (U) GOVERNING COUNCIL REPRESENTATIVE ADAN PACHACHI EXPRESSED GRATITUDE TO THE SECRETARY-GENERAL AND THE UN FOR INVITING THEIR DELEGATION TO THE UN, AND THANKED THE CPA FOR THEIR EFFORTS IN <<IRAQ>>. GC PARTICIPATION IN THE MEETING WAS A CLEAR COUNCIL EXPRESSION OF ITS COMMITMENT TO THE SOVEREIGNTY OF <<IRAQ>> STRESSED UNDER UNSCR 1483. SADDAAM'S TYRANIC REGIME, HE STATED, OPPRESSED ALL IRAQIS FOR A NUMBER OF YEARS; THE BIGGEST AND MOST HORRIFIC EXAMPLES COULD BE FOUND IN THE MASS GRAVES THAT WERE BEING DISCOVERED ALL OVER THE COUNTRY. THE GC HAD CALLED ON A SELECT GROUP OF SECURITY COUNCIL MEMBERS TO PUT FORTH PROPOSALS FOR A SPECIAL TRIBUNALS TO PROSECUTE MEMBERS OF THE OLD REGIME FOR THEIR CRIMES AGAINST HUMANITY.

THE GOVERNING COUNCIL HAD BEEN FORMED THROUGH PAINSTAKING CONSULTATIONS INVOLVING THE CPA AND SRSG AND REPRESENTED THE FULL SPECTRUM OF IRAQI SOCIETY. UNSCR 1483 DID NOT CLEARLY DEFINE THE FUNCTIONS OF THE IRAQI INTERIM AUTHORITY (IIA), ALLOWING FOR FLEXIBILITY AND EXPANSION IN THE ROLE OF THE GC. 12. (U) UK AMBASSADOR GREENSTOCK, IN HIS LAST COUNCIL INTERVENTION ON <<IRAQ>>, RECOGNIZED THE INCREASINGLY IMPORTANT ROLE OF THE UN IN <<IRAQ>>. AS STATED IN UNSCR 1483, THE DAY WHEN IRAQIS GOVERN THEMSELVES SHOULD COME QUICKLY, AND THE GC WAS A CRITICAL ELEMENT IN THE POLITICAL PROCESS TOWARDS AN INTERNATIONALLY RECOGNIZED IRAQI GOVERNMENT. THE SYG WELCOMED THE GC AND NOTED THAT IT WOULD BE A PARTNER IN THE IRAQI-OWNED PROCESS OF CONSTITUTIONAL REFORM. THE CPA WOULD

WORK WITH THE GC TO CREATE CONDITIONS IN <</IRAQ>> CONDUCIVE TO POLITICAL DEVELOPMENT. THE UK, AS PART OF THE CPA, RECOGNIZED THE IMPORTANCE OF SECURITY, AND WOULD WORK TOWARDS ESTABLISHMENT OF THE RULE OF LAW. A MINORITY IN <</IRAQ>> WAS ATTEMPTING TO SABOTAGE THE PROCESS, UNDERMINING INTERNATIONAL EFFORTS TO ASSIST THE CIVILIAN POPULATION. THEY WOULD NOT SUCCEED.

(U) GREENSTOCK WELCOMED A UN ROLE IN REFORM OF IRAQI JUSTICE SYSTEMS, AND PROTECTION OF HUMAN RIGHTS, ESPECIALLY IN DEVELOPMENT OF CIVIL SOCIETY STRUCTURES, PUBLIC ADMINISTRATION, THE SECURITY SECTOR, AND HUMAN RIGHTS MONITORING. THE CPA WAS RESTORING JUDICIAL SYSTEMS AND THE IRAQIS THEMSELVES WOULD HAVE TO DECIDE HOW TO PUNISH PAST CRIMES. IN THIS REGARD, HE ARGUED THAT THE INTERNATIONAL ADVISORY AND MONITORING BOARD (IAMB) TO THE DEVELOPMENT FUND FOR <<IRAQ>> SHOULD HAVE THE POWER TO MONITOR DFI DISBURSEMENTS TO ENSURE THEY ARE CONSISTENT WITH 1483. REFERRING TO THE OIL-FOR-FOOD PROGRAM, HE SAID THERE SHOULD BE NO DISCRIMINATION AGAINST SUPPLIERS. HE SAID FRANCE WOULD SUPPORT A MULTILATERAL FRAMEWORK FOR DONOR CONTRIBUTIONS TO <<IRAQ>>'S RECONSTRUCTION. AS TO THE OIL SECTOR, FRANCE BELIEVES ITS DEVELOPMENT SHOULD BE CONDUCTED ON THE BASIS OF INTERNATIONAL LAW.

RUSSIA: IMPROVED SECURITY LEVERAGE FOR SUCCESS

16. (U) RUSSIAN DPR GATILOV STRESSED THE COMPLEX NATURE OF THE SITUATION IN <<IRAQ>>, AFFECTING THE FUTURE OF THE IRAQI PEOPLE AND STABILITY IN THE MIDDLE EAST. THE ONLY WAY TO ASSIST <</RAQ>> OUT OF THE CRISIS WAS TO RESPECT ITS SOVEREIGNTY AND TERRITORIAL INTEGRITY, AND RIGHT OF THE IRAQI PEOPLE TO DISPOSE OF THEIR OWN NATURAL RESOURCES. RUSSIA AGREED WITH THE CONCLUSIONS OF THE SYG'S REPORT, AND NOTED THAT THE SUCCESSES OF THE INTERNATIONAL COMMUNITY WOULD BE GREATER IF THE SECURITY SITUATION ON THE GROUND WERE MORE STABLE. THE GC WAS A STEP IN THE RIGHT DIRECTION; HOWEVER, THIS STEP HAD TO LEAD TO A LEGALLY ELECTED GOVERNMENT, DETERMINED BY THE IRAOI PEOPLE. THE UN COULD ASSIST IN DEVELOPMENT OF A GOVERNMENT BASED ON THE RULE OF LAW, THROUGH A CLEAR TIMETABLE DEFINED BY A SEQUENCE OF EVENTS. THE SRSG HAD A CRUCIAL ROLE IN ECONOMIC RECOVERY IN <<IRAQ>>, WORKING CLOSELY WITH THE IMF, WORLD BANK, AND UNDP. THE UN SHOULD CONTINUE ITS HUMANITARIAN PROGRAMS FOLLOWING THE PHASE-OUT OF OFF, BECAUSE THESE PROGRAMS WERE CRITICAL TO THE IRAQI POPULATION WHICH HAD SUFFERED YEARS OF DEPRIVATION UNDER THE PRIOR IT WAS NOW IMPORTANT TO TAKE A DECISION ON THE REGIME. SPECIFIC STEPS FOR UN INVOLVEMENT IN <<IRAQ>>, SUPPLEMENTING THE UN ROLE WITH APPROPRIATE FUNCTIONS.

CHINA: CLEAR TIMETABLE FOR POLITICAL PROCESS NEEDED

17. (U) CHINESE DPR ZHANG WELCOMED THE ESTABLISHMENT OF THE GOVERNING COUNCIL IN <<IRAQ>> STATING THAT CHINA SHARED THE VIEW OF THE SYG THAT IT WAS IMPORTANT FOR THE IRAQI PEOPLE TO SEE

RECALLING NEGOTIATIONS OVER UNSCR 1483, PLEUGER ASSERTED THAT IT HAD BEEN AGREED THAT THE INTERNATIONAL ADVISORY AND MONITORING BOARD (IAMB) OF THE DEVELOPMENT FUND FOR <</RAQ>> (DFI) SHOULD HAVE A STRONG MANDATE, ENSURING THAT FUNDS WOULD BE DISPERSED BASED ON OPERATIVE PARAGRAPHS 13 AND 14 OF UNSCR 1483. GERMANY WOULD ALSO WELCOME A MULTILATERAL INSTRUMENT FOR BILATERAL CONTRIBUTIONS TO IRAOI RECONSTRUCTION. TRANSPARENCY WAS KEY TO DISTRIBUTION OF ECONOMIC RESOURCES, AND THE TERMS OF REFERENCE OF THE IAMB SHOULD REFLECT THAT THE BODY WILL NOT ONLY ADVISE, BUT ALSO MONITOR TRANSACTIONS THROUGH ITS AUDITORS.

25. (U) BULGARIAN PR TAFROV PRAISED THE GC, WHICH HE CALLED A POSITIVE DEVELOPMENT FOR <<*IRAQ>>*. TAFROV NOTED THE CENTRAL ROLE THE UNITED NATIONS WOULD PLAY IN BRINGING THE POLITICAL PROCESS TO FRUITION. THE UN COULD PARTICULARLY IMPROVE THE HUMAN RIGHTS SITUATION IN <*IRAQ>>*, WHICH NEEDED SPECIAL ATTENTION AFTER YEARS OF THE ABUSIVE DICTATORSHIP. THE NATIONAL RECONCILIATION PROCESS IN <<IRAQ>> COULD BE PROMOTED THROUGH APPROPRIATE JUDICIAL MEASURES FOR HUMAN RIGHTS VIOLATIONS. DONORS SHOULD MAKE CONTRIBUTIONS TO RECONSTRUCTION AS SOON AS POSSIBLE BECAUSE THE IRAQI PEOPLE REMAINED VULNERABLE. <<IRAQ>> NEEDED THE UN EXPERTISE TO MOVE TOWARDS A MARKET ECONOMY, AFTER YEARS OF WAR AND POVERTY. <<IRAQ>> WAS A "VAST BUILDING SITE" FOR WHICH THE INTERNATIONAL COMMUNITY COULD HELP PROVIDE AN INSTITUTIONAL AND LEGAL FRAMEWORK FOR REFORM, PUTTING AN END TO THE IRAQI "NIGHTMARES."

CAMEROON: UN MILITARY-POLICE PRESENCE CANNOT BE RULED OUT

28. (U) CAMEROONIAN PR BELINGA-EBOUTOU EXTENDED A WARM WELCOME TO THE GOVERNING COUNCIL STATING THAT ITS CREATION WAS A CRITICAL TO THE ESTABLISHMENT OF NORMAL ECONOMIC AND DEMOCRATIC ORDER. CAMEROON SUPPORTED THE SYG'S RECOMMENDATIONS IN HIS REPORT AND AGREED THAT URGENT ACTION NEEDED TO BE TAKEN. ON THE ISSUE OF SECURITY, THE OPTION OF A UN MILITARY OR POLICE PRESENCE SHOULD NOT BE RULED OUT FOR THE FUTURE.

HIS WORK IN **<<IRAQ>>** AND THE WORK OF THE UN STAFF EXEMPLIFY THE VITAL ROLE FOR THE UNITED NATIONS ENVISAGED BY PRESIDENT BUSH AND PRIME MINISTER BLAIR IN THE HILLSBOROUGH STATEMENT.

I WOULD ESPECIALLY LIKE TO WELCOME MR. ADNAN PACHACHI, MR. AHMED CHALABI AND MS. AQEELA AL-HASHIMI THE THREE MEMBERS OF THE GOVERNING COUNCIL THAT ARE HERE WITH US TODAY. FOR THE FIRST TIME IN ALMOST FIFTY YEARS IN <<IRAQ>>, THERE IS NO LIMIT ON THE FREEDOM OF EXPRESSION IN THAT REGARD. IN <<IRAQ>> TODAY, ALL SHADES OF OPINION HAVE FULL FREEDOM TO COMPETE IN AN OPEN MARKET OF IDEAS. YOUR PRESENCE HERE IS A POWERFUL SYMBOL OF THAT FREEDOM.

POLITICAL FRAMEWORK

TWO MONTHS AGO TODAY, THIS COUNCIL ADOPTED RESOLUTION 1483, WHICH CREATED A FORWARD PATH FOR THE COALITION AUTHORITY AND THE UNITED NATIONS ON THE GROUND IN **<<IRAQ>>**. RESOLUTION 1483

AFFIRMED OUR COLLECTIVE COMMITMENT TO THE FREE POLITICAL DEVELOPMENT OF AN INTERNATIONALLY RECOGNIZED, REPRESENTATIVE GOVERNMENT OF <<IRAQ>>. TODAY, JUST TWO MONTHS LATER, THE IRAQI PEOPLE HAVE MADE TREMENDOUS PROGRESS ON THE CHALLENGING TRANSITION TO DEMOCRACY WITH THE FORMATION OF THE 25-MEMBER GOVERNING COUNCIL, ON JULY 13, NINE DAYS AGO. AS THE SECRETARY-GENERAL NOTED IN PARAGRAPH 107 OF HIS REPORT, THE FORMATION OF THE GOVERNING COUNCIL WAS ANTICIPATED IN RESOLUTION 1483 ANTICIPATED, AND AS THE SECRETARY GENERAL NOTED IN PARAGRAPH 107 OF HIS RECENT REPORT, THE GOVERNING COUNCIL PROVIDES A BROADLY REPRESENTATIVE IRAQI PARTNER --FOR THE FIRST TIME IN DECADES, THERE IS A NATIONAL POLITICAL BODY THAT REFLECTS THE RICH MOSAIC OF IRAQI SOCIETY. THE ESTABLISHMENT OF GOVERNMENT BY AND FOR THE IRAQI PEOPLE AS ENVISAGED IN SECURITY COUNCIL RESOLUTION 1483 IS UNDERWAY. THE GOVERNING COUNCIL DESERVES THE FULL SUPPORT OF THE INTERNATIONAL COMMUNITY, ESPECIALLY THIS BODY.

THE ROLE OF WOMEN IN **<<IRAQ>>'S** POLITICAL DEVELOPMENT SHOULD NOT BE OVERLOOKED. MORE THAN SEVENTY WOMEN PARTICIPATED IN A DAY OF WORKSHOPS ON JULY 9 ENTITLED "VOICE OF WOMEN IN **<**IRAQ>>." THAT EVENT WAS ORGANIZED BY A STEERING GROUP OF IRAQI WOMEN, WITH ASSISTANCE AND PARTICIPATION BY THE AUTHORITY AND THE UNITED NATIONS, INCLUDING UNIFEM, UNDP, AND UNICEF. THE SAME STEERING GROUP WILL PUBLISH THE WORKSHOP RECOMMENDATIONS ON CONSTITUTION AND DEMOCRACY, AMONG A NUMBER OF OTHER ISSUES.

SECURITY
