3. (SBU) LOCAL HUMAN RIGHTS ACTIVIST [REDACTED] AND TWO OF HIS COLLEAGUES [REDACTED] INFORMED [REDACTED] THAT THEY VISITED THE FAMILY DURING THE WEEK OF MARCH 3. THE FAMILY, ACCORDING TO [REDACTED] SAID THAT [REDACTED] HAD RECENTLY VISITED THEIR HOME AND ASKED THEM TO SIGN A LETTER REQUESTING THAT [REDACTED] BE TRANSFERRED FROM GUANTANAMO. THE FAMILY HAD REFUSED, AND [REDACTED] HAD REPORTEDLY THREATENED THEM (WITH WHAT, HE DID NOT KNOW).
