Press Guidance of May 7: The February 2004 ICRC Report (on conditions of detainees in Iraq) was provided to CPA and US Military authorities in Baghdad in February. The Department of State first saw a copy of the report in March.

Secretary's May 10 interview with Juan Williams of NPR on the issue. (Transcript provided by Office of the Spokesman 2004/517 on May 11, 2004)

Mr. Williams: "ICRC President Jacob Kellenberger said he met with you as well as NSC Advisor Rice and Deputy Defense Secretary Wolfowitz, about the prison abuse situation as far back as January. Is that true? "

Secretary Powell: "Yes. We meet with Mr. Kellenberger every time he comes to town. We think very highly of the International Committee of the Red Cross. And as you know, Juan, the way they work is when they do their inquiries and investigations, they take what they find directly to the command involved or to the organization involved in the field, and subsequently they will brief up the chain. And so Mr. Kellenberger would brief me on these matters when he was in town. And when he did brief, we would discuss these matters within the interagency process, and I think the Pentagon is now looking at all the information that the ICRC has provided to us over the last year or so to see which findings they presented we did respond to and which ones have not yet been responded to yet. Mr. Kellenberger, when I spoke to him last week on the telephone, he was encouraging us to put out what we did correct and also to take note of what has yet to be corrected."

ICRC press guidance on the issue: "President Kellenberger visited Washington in January and discussed detention matters with Condoleeza Rice, Paul Wolfowitz, and Colin Powell. The main focus was on Guantanamo Bay, but Iraq and Afghanistan were also discussed. These meetings were part of the regular bilateral contacts between the ICRC and different governments. Mr. Kellenberger referred to the ICRC's upcoming report on US detention in Iraq, but did not discuss the contents of this report."

Importance:

I would very much appreciate your assistance with the answer to this QFR from Senator Feingold for D

As I understand it, the International Committee of the Red Cross and Red Crescent alerted senior officials at both the Department of Defense and the Department of State about alarming abuses of Iraqi prisoners directly in mid-January. Press reports indicate that the ICRC communicated concern directly to both Secretary Powell and Deputy Secretary Wolfowitz. So regardless of whether other reports made it onto the desks of the right people, the message was delivered at very high levels at that time. I would like to ask both Secretary Armitage and Secretary Wolfowitz, what action did your respective Departments take after the ICRC delivered that very troubling message?
