Please note that the time for the Policy Coordinating Committee (PCC) on Europe and Eurasia on February 20 that will address U.S.-Russia relations has been changed. It will be at 4:30 p.m. in Room 4517 of the State Department.

Attached for discussion at the PCC is a State-drafted annotated version of the Camp David Action Checklist approved by President Bush and President Putin in September 2003.
