This investigation was initiated upon notification from HQ, U.S. Army Criminal Investigation Command, Fort Belvoir, VA 22060-5506 who received information from the Inspector Generals Office that SFC HHC, 2/325th Airborne Infantry Regiment (AIR), Fort Bragg, NC 28310 (FBNC), witnessed a detainee being abused by PFC 61cb6-4

Investigation established PFC did not commit the offense of Assault or Failure to Obey a General Order as originally reported by SFC. A review of eyewitness accounts of the incident and the review of CFLCC Rules of Engagement which allow a soldier to use appropriate force to detain a person thought to be involved in terrorist acts revealed PFC acted appropriately when detaining a suspected terrorist.
