INVESTIGATIVE SUMMARY:

ON 10 May 04, This office initiated a Target Analysis File in regards to possible detainee abuse in the Al-Azimiyah Palace, Baghdad, Iraq. On 17 May 04, during an administrative review of this file by this office it was determined to open a Report of Investigation.

Investigation established probable cause to believe Mr. [REDACTED] Mrs. [REDACTED] Mr. [REDACTED] Mr. [REDACTED] and Mr. [REDACTED] committed the offense of False Official Statement when they reported they were abused that they knew to be false.

Investigation did not prove or disprove Mr. [REDACTED] was deceased. Statements provided by the family members were the only indication Mr. [REDACTED] was deceased, but based on their lack of credibility this office could not prove or disprove the death.

On 16 Jun 04, CPT [REDACTED] Chief of Criminal Law, 3rd Corp, Office of the Staff Judge Advocate, Camp Victory, Iraq opined sufficient evidence to establish probable cause to believe the offenses of Aggravated Assault, Cruelty and Maltreatment, Forcible Sodomy and Indecent Assault did not occur. Further, CPT [REDACTED] opined sufficient evidence to establish probable cause existed the victims committed the offense of False Official Statement.

Basis for Investigation: This investigation was initiated based on notification from the 22nd MP Battalion, of possible detainee abuse in various locations.

On 6 May 04, Mr. [redacted] CACI, 1st Cavalry Division Interrogation Facility, Baghdad, IZ; was interviewed by [redacted] (NFI) and stated the MPs [redacted] were not following instructions on the treatment of one of his sources and would harass him. He heard [redacted] shaved the beard of a detainee. Mr. [redacted] stated he heard [redacted] there was possible abuse Al Azimiyah Palace (NFI), where 5th Group conducted their interrogations. Mr. [redacted] related he never witnessed any abuse occur; however, he heard [redacted] (NFI) describe a technique where he would circle the detainee's nipple with a [redacted] cigarette but never touch it. He said [redacted] was currently at the Tikrit Division Interrogation Cell (NFI).

On 7 May 04, Mr. [redacted] CACI, 1st Cavalry Division Interrogation Facility, Baghdad, IZ; was interviewed by [redacted] (NFI) and stated he over [redacted] heard [redacted] (NFI) say he shaved a detainee's beard and put women's red [redacted] underwear on him. Mr. [redacted] also stated he heard a detainee was shot in the head with a [redacted] rubber bullet. Mr. [redacted] related he heard unidentified individuals tell the MPs to "soften up" [redacted] the detainees. Mr. [redacted] further related certain individuals took copious notes and may have [redacted] more information. He identified them as [redacted] (NFI) and [redacted] (NFI) both located at Abu Ghraib Prison, Baghdad, IZ.

About 1130, 12 May 04, SA [redacted] interviewed Mr. [redacted] CACI, 1st CAV Division Interrogation Facility (DIF), Baghdad, IZ, who re-interated his initial statement. Mr. [redacted] stated he worked in approximately three sections, while at Abu G. [redacted] Prison, which was the screening section, Interrogating with Tiger Teams, and the Detainee Assessment Board. Mr. [redacted] worked at the Abu G. Prison between Sep 03 and Apr 04. Mr. [redacted] never seen any detainee abuse, but stated he saw the results of abuse, which the [redacted] detainees would describe to him during the initial screening phase, i.e. wounds to their chest possibly from battery cables being connected to their chest, electrocuting, cigarette burns, wine bottle placed in their anus. When Mr. [redacted] questioned the detainees about who abused them, [redacted] they stated U.S. soldiers and [redacted], but unsure of the incident location. The [redacted] detainees, while bags over their head described the U.S. soldiers only by observing the typical desert combat boots and pants, but did not provide any further details. When Mr. [redacted] abused them he would remove the bag from their head. The detainees never described [redacted] Mr. [redacted] Apparently, Mr. [redacted] would wear different types of clothing to include [redacted] military clothing. Mr. [redacted] re-interated Ms. [redacted] (NFI) took notes on what she [redacted] observed and heard, while at the Abu Prison. Mr. [redacted] suspected a Task Force was working [redacted] with Mr. [redacted] at a Palace, unknown location, but could not provide any details. Mr. [redacted] also mentioned Ms. [redacted] roommate, Ms. [redacted] translator, Abu G. Prison, would [redacted]

possibly have further details of possible detainee abuse. Mr. [redacted] stated a medical doctor, Abu G. Prison conducted physical exams on the detainees, usually on the second day of in-processing, so the medical unit would possibly have copies of their treatment records, revealing any injuries. No further details were provided to this office

About 1138, 12 May 04, SA [redacted] interviewed Mr. [redacted] who stated he was interviewed by MAJ [redacted] who discussed possible abuse allegations which he related he had no first hand knowledge of. He stated Mr. [redacted] statement he overheard could have been taken out of context because he did hear the whole conversation. He stated SPC [redacted] (NFI) was the person who gave specific orders to the MPs to not harass his source. Mr. [redacted] related Mr. [redacted] possibly shaved the detainee's beard for several reasons to include identification purposes or sanitary purposes. He was unaware of women's underwear being placed on the detainee. Mr. [redacted] stated Mr. [redacted], Linguist, CACI, 1st Cavalry Division, APO AE 09342, interviewed a detainee who alleged he was abused while at AL-Azimiyah Palace.

About 1230, 12 May 04, SA [redacted] interviewed Mr. [redacted] who stated he was he primary interviewer for Mr. [redacted], Military Police Number [redacted]. Mr. [redacted] related Mr. [redacted] was captured on 4 Apr 04 and was brought to their Detention Interrogation Facility (DIF) on 29 Apr 04. He related Mr. [redacted] alleged he was taken to the Al-Azimiyah Palace and was struck in the face several times by whom he believed to be an Iraqi named [redacted]. He said he believed the man to be Iraqi by his dialect and appearance. He stated he was wearing a bag over his head during the interrogations but [redacted] removed his hood once and looked at Mr. [redacted]. He knew his name to be [redacted] because he heard another man he believed to be Iraqi call him that once. Mr. [redacted] told Mr. [redacted] burned him with cigarettes on the foot three times and struck him on the left side of his head so many times he bled from his ear. Mr. [redacted] stated he had no bruising on his face or fresh burn marks on him to substantiate such allegations and was given a medical exam when he was received. He related Mr. [redacted] was in Al-Azimiyah Palace for approximately 18 days. He related Mr. [redacted] was a Major in the old Iraqi Army and was incarcerated twice for dereliction of duty and spent a year in prison under the Old Iraqi regime. Mr. [redacted] stated Mr. [redacted] had trouble discerning his current incarceration from when he was incarcerated under the old regime. Mr. [redacted] further stated Mr. [redacted] faked a heart attack on 4 May 04. Mr. [redacted] stated he coordinated with two individuals at Al-Azimiyah Palace, [redacted] (NFI) and [redacted] (NFI) who came to the DIF location and positively identified Mr. [redacted] as the person they interviewed and brought the interrogation reports which verified the interviews. Mr. [redacted] related the men said they refuted the allegations made by Mr. [redacted] and Mr. [redacted] could not explain his story when confronted by Mr. [redacted] with the reports. He related Mr. [redacted] just gave him a look

he described as he was just caught in a lie. Mr. [redacted] provided this office with a photograph and medical evaluation of Mr. [redacted] (See documents)

About 1328, 12 May 04, SA [redacted] reviewed the medical records on file of Mr. [redacted] which reflected an incident when Mr. [redacted] faked a heart attack. Nothing else remarkable was seen.

About 0930, 15 May 04, SA [redacted] and SA [redacted] interviewed Mr. [redacted] AKA [redacted], Interpreter, 1st Cavalry Division DIF, Titan Corporation, APO AE 09342 who stated he was the interpreter for Mr. [redacted] when Mr. [redacted] was interviewed. He reiterated what Mr. [redacted] stated in that Mr. [redacted] related a man he claimed to be an Iraqi abused him when he was detained at the Al-Azimiyah Palace. Mr. [redacted] stated the man's name could also have been [redacted]. Mr. [redacted] related he was not familiar with [redacted] and has not heard anyone mention his name. Mr. [redacted] further related this was the only detainee he talked to which mentioned being abused in the Al-Azimiyah Palace. Mr. [redacted] stated sometime in Aug 03, while he was working in Abu Ghraib Prison, he witnessed a female soldier he believed to be U.S. Army Military Police, make a detainee jump up and down and then roll left to right on the ground in what he believed to be a 150 degree Fahrenheit temperature clothed in only his underwear. He stated this went on for about twenty minutes and the detainee was at the point where he collapsed several times and when the detainee attempted to drink water he would vomit. Mr. [redacted] related he knew the female soldier's first name as [redacted] (NFI) and she always worked with an interpreter named [redacted] (NFI) who was also employed by Titan Corporation. Mr. [redacted] stated Mr. [redacted] would know exactly who [redacted] was and would be able to give more details on this incident and possibly other incidents.

About 0900, 20 May 04, this office received the final Information Report from the Baghdad Correctional Confinement Facility (BCCF), Abu Ghraib, IZ, APO AE 09342. The report included the AIR from SA [redacted] which detailed the interviews of Ms. [redacted] and Mr. [redacted] (See AIR for details)

About 1015, 20 May 04, SA [redacted] and SA [redacted] this office interviewed Mr. [redacted] date of birth [redacted] Place of Birth [redacted]

assistance from Mr. [redacted] Linguist, Titan Corporation, 1st CAV Detention Interrogation Facility (DIF), Baghdad International Airport (BIAP), Baghdad, IZ, who reiterated his previous statement he provided to Mr. [redacted] on a prior interview. Mr. [redacted] described [redacted] (Iraqi interrogator) as a white male, combed, gray hair, no mustache, light white beard, who wore a white t-shirt, brown trouser, sneakers, and rubber gloves. Mr. [redacted] stated after he was apprehended from his

residence he was moved to three different locations: 1) Alazamiya, Baghdad (where all the abuse took place), Unknown location, Taji, IZ, and 1CD DIF. While at Alazamiya, (underground room) Mr. [redacted] had his hood pulled off his head, so he could see that the interrogators were Iraqi civilians on several occasions and replaced back on his head. Mr. [redacted] was handcuffed to the floor in the underground room. Mr. [redacted] was interrogated on approximately five to six occasions. The abuse by Mr. [redacted] toward Mr. [redacted] included pinching his nose, while pouring water into his mouth; stuck a wooden stick up to his anus region, but as they touched his anus, Mr. [redacted] told Mr. [redacted] he would tell them anything and sign any documents. Mr. [redacted] also had a wooden stick jammed between his testicles and anus region and also had his testicles electrocuted. Mr. [redacted] head was hit by Mr. [redacted] on several occasions. Mr. [redacted] was a smoker and also burned Mr. [redacted] on the ankle with a cigarette. Mr. [redacted] never seen or heard of Mr. [redacted] (NFI) abusing him, but did see him present during the interrogations. Mr. [redacted] drew a picture of the Alazamiya location. (see picture for details) Mr. [redacted] never seen or heard any American Soldiers during the interrogation, while at Alazamiya location. Mr. [redacted] was then transported to an unknown location, Taji, IZ, where he was treated well by the American soldiers. The American soldiers brought him bread, water and took him to the restroom on many occasions. Mr. [redacted] received a medical screening, while at an unknown location, Taji, IZ. Mr. [redacted] was then transported to the 1CD DIF, BIAP, Baghdad, IZ.

About 0955, 22 May 04, SA [redacted] and SA [redacted] interviewed Mr. [redacted] Interpreter, CJTF-7, Titan Corporation, Camp Slayer, who related he worked with SPC [redacted] 205th BDE (NFI), and related everything she was doing was in accordance with the rules of engagement and never witnessed abuse of detainees while working at Abu Ghraib with SPC [redacted]

About 1730, 22 May 04, this office received statements in reference to Ms. [redacted] Ms. [redacted] Detainee NDRS# [redacted] Detainee NDRS# [redacted] Detainee NDRS# [redacted] from the 22nd MP BN (CID). The statements were unsigned and not dated. The statements allege abuse at various locations to include Al-Azimiyah Palace. (See statements)

Forces broke the front door and threw distracting devices in the house. After entering the house all the occupants' hands were tied behind their backs. All the women in the house were tied to the stairs in the house and the men were taken to the kitchen and they were all hooded or blind folded. The detainees alleged the house was ransacked and approximately \$80,000.00 US dollars and \$30,000,000.00 Iraqi dinner were stolen. In addition to the money all the gold in the house and women's jewelry were stolen and the Americans broke all the windows in the vehicles and the furniture in the residence. Detainee [redacted] related he was hit in the head with a wooden object when they stormed the house and was cut and almost knocked unconscious. Detainee [redacted] stated he was hit in the head as well and knocked to the ground. When he was dragged into one of the HMMWV's he was kicked in the head. During the raid no one spoke to the Iraqi's and the house was inspected without anyone going with them. All the men were taken from the house to Ruthwania Palace. After they arrived at the Palace they were thrown to the ground and their hands were untied and replaced with handcuffs, which were put on very tight. Detainee [redacted] related his father was with him; however, his father was in poor medical condition and was taken to an unknown hospital. He related he has not heard about his father nor does he know what his current condition is. While at the Palace they were forced to kneel on the ground (stones) with their faces on the ground for four days and nights. When it was dark they were taken inside the palace and placed in the same position on the concrete floor. All the detainees stated they were hooded the entire time and were unable to see. Further, they were not fed and were not allowed to sleep, during those four days. When some of the detainees asked what they had done, they were kicked and punched on the head and back. Detainee [redacted] stated he was hit so hard he lost consciousness. During those four days at the palace the Americans released dogs on them; however, the dogs only bit their clothing and never caused any physical injuries. Detainee [redacted] also related that at one point he was being interrogated and the interrogator lifted up his hood and insulted him by threatening to shave his head and beard and make him wear woman's clothing. The interrogator also stated he was going to have sexual relations with the Detainees mother. He described the interrogator as a white male with blond hair and a blond mustache, about 35 years old, with blue green eyes, about six foot tall and of muscular build, he was wearing an army DCU cap. Detainee [redacted] related he did not know if the interrogator physically assaulted him because he was hooded, except for the time when he was insulted by the interrogator. Detainee [redacted] related he lost feeling in his right hand because the handcuffs were to tight while he was at the Palace and he was kicked very hard in the right thigh. All the detainees related they were punched and kicked several times while at the palace. They also related the abuse stopped after they left the palace and they have all been treated very well since arriving at Abu Ghruyeb. They were asked as to why they had so much money in the residence, which they replied they are a wealthy family as they are in the transportation business with many busses and vehicles.

 NDRS # [redacted] who related he was the uncle of [redacted] b7C-4, b6-4, b7C-5, b6-5 however, he was very poor and did not associate with the family. Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 related he was detained with his son's and one of his son's friends, who was visiting. They were not with [redacted] b7C-4, b6-4, b7C-5, b6-5 when they were detained. Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 related the only thing he knows of that family is they are well respected in the community and provide money for the poor. He did not believe the family would do anything against coalition forces and that [redacted] b7C-4, b6-4, b7C-5, b6-5 had a man who worked for her who wanted to work for the coalition forces and she encouraged him to go and help. He also related that he heard Huda [redacted] b7C-4, b6-4, b7C-5, b6-5 and her sister and brothers turned themselves in because they wanted to prove their innocents. Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 stated he believed IP [redacted] b7C-4, b6-4, b7C-5, b6-5 was a bad man and tried to extort money from the family and when they refused, he captured and tortured them and brought false allegations against them. He denied any knowledge or involvement in attacks against coalition forces and did not know why he was detained, as the Americans searched his house and did not find anything other than one of his son's pistols. His son is an Iraqi Police man and was authorized the pistol and when the Americans came into the house he told them about the weapon and brought it to them.

About 1420, 24 May 04, SA [redacted] b7C-1, b6-1 this office and Interpreter [redacted] b7C-3, b6-2 Abu Ghraib CID, interviewed Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 NDRS # [redacted] b7C-4, b6-4, b7C-5, b6-5 who related the same thing as his father and stated that he was tortured by IP [redacted] b7C-4, b6-4, b7C-5, b6-5 while at the palace. IP [redacted] b7C-4, b6-4, b7C-5, b6-5 informed all of the persons captured with him that if they made statements about [redacted] b7C-4, b6-4, b7C-5, b6-5 and her family they would be set free. Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 refused and was kicked and punched severely for several days. Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 stated IP [redacted] b7C-4, b6-4, b7C-5, b6-5 tried to extort money from [redacted] b7C-4, b6-4, b7C-5, b6-5 and she refused and that is why the family was captured. Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 stated he knew [redacted] b7C-4, b6-4, b7C-5, b6-5 family although he was poor and they were wealthy he saw them many times and knew the family to be good people and not against the coalition forces. Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 related that he had a hernia surgery two days prior to being detained and was laid up in bed when he was detained.

About 1530, 24 May 04, SA [redacted] b7C-1, b6-1 this office and Interpreter [redacted] b7C-3, b6-2 Abu Ghraib CID, interviewed Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 NDRS # [redacted] b7C-4, b6-4, b7C-5, b6-5 who related he was visiting his friend, detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 because he needed help after his surgery, when he was detained. Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 stated he did not know why he was detained and he did not know who attacks coalition forces nor has he ever attacked coalition forces. Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 also stated IP [redacted] b7C-4, b6-4, b7C-5, b6-5 tried to get him to make false accusations against [redacted] b7C-4, b6-4, b7C-5, b6-5 and her family and that if he did he would be let free. Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 refused and was severely beaten by IP [redacted] b7C-4, b6-4, b7C-5, b6-5. Detainee [redacted] b7C-4, b6-4, b7C-5, b6-5 stated he did not know [redacted] b7C-4, b6-4, b7C-5, b6-5 or her family, just that they had a good reputation in the area for helping people in need and that IP [redacted] b7C-4, b6-4, b7C-5, b6-5 had tried to extort money from [redacted] b7C-4, b6-4, b7C-5, b6-5 and when she refused he captured her and made people give false accusations against her and her family.

About 1000, 25 May 04, SA [redacted] b7c(1), b6(1), b7C this office and Interpreter [redacted] b7c(1), b6(1), b7C Abu Ghryeb CID, interviewed detainee [redacted] who was stated she was captured on 13 Jan 04. Her house was searched; however, nothing was found. She was taken to Kurkurk, where no abuse happened; however, she was later taken to a detention facility on BIAP, where a doctor checked her out. While at BIAP she was forced to stand against a wall for long periods of time, she subsequently fainted because she had not had any food for two or three days. She was later interrogated and she was accused of lying and she was placed in a dark room with loud noises from a stereo being played (the noises sounded like people screaming and crying). An unknown black female, US Solider guard came and threw her around the room from one wall to the other until she fainted. The female stripped her down to her bra and underwear and brought her out so the men would laugh at her. The male interrogator told her he was the devil and he and the black female made her crawl around on her hands and knees for hours. The female would hit her with a long stick when ever she would slow down while crawling. The male guards would all laugh at her and the female would pour cold water on her as she crawled. The guards brought in her nephew and took off all of his clothes and made her and her nephew look at each other. The female guard exposed the detainee's breast and forced her nephew to look at her. The female continued to beat her while a male beat her nephew. They were again ordered to crawl on the floor and the female pulled her hair, to the point it took her breath away and slammed her head against a wall. If she tried to sleep the female would pour water in her ears to wake her up. The female beat her with a plastic chair until the chair broke. The detainee stated she had a plastic sliver in her foot, that she was not allowed to take out, which subsequently caused an infection in her foot. She was beaten against a wall until she passed out, and again water was poured in her ear to wake her up and the female threw her leg numerous times against a wall. Later the interrogator brought in a meat grinder and told her they were going to grind her up in the meat grinder if she didn't talk. A machine (believed to be a vacuum cleaner) was brought in to her room and she was told to clean up the room. The detainee stated she did not know how to use it and she was subsequently beaten with the vacuum cleaner hose on her face and nose. She was placed back in a small room with no lights and was given her clothes back after the clothes were soaked in water. At night when she tried to sleep they would come in and wake her up and not allow her to fall asleep and she was forced to stand. She was not allowed to use the bathroom and if she asked the female would beat her. The detainee stated there was a nice guard who allowed her to see a doctor who looked at her foot and gave her slippers to wear. She stated she saw the doctor at 0400 in the morning and the doctor pulled out the sliver. The doctor checked up on her two days later and changed the dressings on her foot. The detainee stated she was in the cell for five days until she was transferred to a better place. She was taken to Abu prison where she received medical treatment for her injuries and given medication and she stated she has been treated very well at Abu prison. Detainee stated she believed she was going to be released soon and did not want this investigation to slow that process. Detainee provided a written statement. (See statements)

About 1000, 25 May 04, SA [redacted] b7c-1, b6-1 Conducted a search for a detainee, NDRS # [redacted]; however, no record was found, that same number belonged to an Iraqi prisoner, who was arrested by Iraqi police and had nothing to do with attacks on coalition forces. In addition, the detainee with that number has been in custody since Aug 03.

About 1400, 25 May 04, SA [redacted] b7c-1, b6-1 interviewed Mr. [redacted] b7c-4, b6-1 CACI Screener, [redacted], who provided a statement documenting his knowledge of suspected abuse detainees informed him of during his screening process. (See statement)

AGENTS COMMENT: Mr. [redacted] b7c-4, b6-4 related he informed his supervisor, Mr. [redacted] b7c-2, b6-3 CACI Screener Supervisor, Abu Prison, IZ, of all Detainees who informed him of abuse. Questioned Mr. [redacted] who related Mr. [redacted] did inform him of all alleged abuse. Mr. [redacted] related he did not have any additional information than what Mr. [redacted] provided.

About 1300, 31 May 04, SA [redacted] ^{b7c-1, b6-1} this office and Interpreter [redacted] ^{b7c-2, b6-2} Abu Ghraib CID, verbally advised Detainee [redacted] ^{b7c-1, b6-1, b7c-5, b6-5} of his legal rights, which he waived and denied any knowledge or involvement in attacks against Coalition Forces. Detainee [redacted] related he did not know who was responsible for the attacks. Detainee [redacted] related he was physically abused while at the Palace, he was pulled by his penis, kicked, punched, hit with a hard object and a water bottle was forced up his rectum. He was forced to sign a statement; however, Detainee [redacted] related he did not know how to read or write. Detainee [redacted] related a hood was placed over his head and he could not see anyone. Detainee [redacted] related he was very ashamed of the abuse against him; however, he did not know who tortured him and he did not want to say Americans did it because he could not see anyone. Detainee [redacted] related he heard people speaking English and a man speaking Arabic with a Lebanese accent. He was subsequently transported to an IP station and then transferred to Abu Prison. Detainee [redacted] related he was not abused while at Abu Prison or at the IP Station. Detainee [redacted] related he did not know [redacted] ^{b7c-1, b6-1, b7c-5, b6-5} or her family and never participated in attacks with them.

About 1420, 31 May 04, SA [redacted] ^{b7c-1, b6-1} this office and Interpreter [redacted] ^{b7c-2, b6-2} Abu Ghraib CID, verbally advised [redacted] ^{b7c-1, b6-1, b7c-5, b6-5} of his legal rights, which he waived and denied any knowledge or involvement in attacks against Coalition Forces. Detainee [redacted] related he was physically abused while at the Palace. A hood was placed over his head and when he was taken out of the vehicle he was pulled by his penis and forced to stand in one location for several hours. Detainee [redacted] is handicapped and suffers from a bone deficiency. He has several surgery scars and related his bones are very weak. While he was forced to stand, he was punched, kicked and struck with a hard object many times in the kidney area, back and stomach. He was subsequently taken to another location and he heard his sisters in the room. While in the room an unknown person threw a person on the Detainee, which he later found out was his brother [redacted] (NFI). The Detainee related his sisters told him it was his brother and that they thought he was going to die. The Detainee managed to lift up his hood and say his brother who was naked and bleeding severely and had bruises all over his body. The next day an unknown man came and took the Detainee to a hill and kicked him down the hill. The Detainee related he suffered several cuts and bruises to his nose as a result of rolling down the hill. His hood was removed for a short time, when he was at the bottom of the hill, the detainee related he saw a black male, who was wearing US military clothing, of medium height and build and about 30 yrs of age, a white male, short and of medium build and about 30 yrs of age and [redacted] ^{b7c-1, b6-1, b7c-5, b6-5}. The black male asked [redacted] if he saw his brother and told him his brother was dead and that he to was going to die and that he would beat him as not to leave marks so he could not complain about the abuse. The Detainee related he was pulled by his penis, and water was forced up his rectum, he was also punched and kicked several times. He was at the palace for five or six days and abused the entire time, he was subsequently taken to an IP Station where he was informed his brother was brought in

dead and six others were brought in tortured. The Detainee related he did not know which IP Station he was taken to. The Detainee related he was not mistreated at the IP Station or while at Abu Prison. The Detainee related he did not witness IP [redacted] do any of the abuse, but IP [redacted] did push the Americans to conduct the abuse.

AGENTS COMMENT: The Detainee is handicapped, his legs and arms are not the same length, he has had surgeries on his legs; however they still appeared to be deformed and he had trouble walking. The Detainee related he and his family went to talk to the Americans and they were not captured. He further related that [redacted] had them arrested because his sister refused to pay him money.

About 0900, 2 Jun 04, SA [redacted] ^{b7c-b66-1} coordinated with MAJ [redacted] ^{b7c-3, b6-3} who provided a copy of a list of detainees captured by CJSODF. MAJ [redacted] further related he would provide this office with copies of the detention logs and memorandums in reference to Rules of Engagement pertaining to interrogation. (See list for details)

Received Final Information Report from PIT, 75th MP Det (CID), which contained the AIR of SA [redacted] (See AIR)

About 1130, 5 Jun 04, SA [redacted] ^{b7c-1, b6-1, b2}, this office, conducted a site survey of the detention facility which was located in the basement of an adjacent building to the ODA 554 living quarters. The detention room was approximately 12 feet by 10 feet and was empty of any furnishings. There were several chains approximately three feet in length attached to the floor and key type padlocks attached to the end, which was utilized for securing a detainee. It was determined that the length of the chain was sufficient for a detainee to lie down, sit in the up position and reach his head with his/her hands to consume water and food. There was nothing of evidential value during the site survey. SA [redacted] ^{b7c-1, b6-1} exposed numerous digital photographs utilizing a Kodak Easyshare CX6330. (See compact disc for details)

About 1300, 5 Jun 04, SA [redacted] ^{b7c-1, b6-1} verbally interviewed SFC [redacted] ^{b7c-3, b6-3} Intelligence Officer, [redacted] ODA 554, B CO, 2nd BN, 5th SFG, Fort Campbell, KY (deployed to Iraq) who stated he has never seen any detainee being abused and he has never abused a detainee. SFC [redacted] stated his unit usually has enough evidence on a detainee that there is no need to force a detainee to talk. SFC [redacted] stated he has never seen or used a dog for interrogation purposes. SFC [redacted] stated on one occasion he told Mr. [redacted], Translator, [redacted], Titan Corporation, Fairfax, VA (working in Iraq) to listen at the door outside of the holding cell to hear what the detainees were talking about. SFC [redacted] stated Mr. [redacted] overheard one detainee reassure the other detainee that after they get transferred to the "airport" they would claim they were abused and subsequently released. SFC [redacted] stated he has heard through numerous sources there was a lawyer

SSG [redacted] stated he interrogated Mr. [redacted] and use a direct approach technique where he presented intelligence to Mr. [redacted] and he admitted to attacks. SSG [redacted] related he has intelligence which states detainees are being instructed on how to claim abuse while under apprehension to ensure a quick release. SSG [redacted] further related Mr. [redacted] is never present during interrogations. (See certificate and statement)

About 1600, 5 Jun 04, SA [redacted] and SA [redacted] advised Mr. [redacted] of his legal rights, which he waived and denied ever being present during interrogations of detainees except on one occasion. Mr. [redacted] stated he was asked to sit in a chair when Ms. [redacted] was being interrogated because she said she knew Mr. [redacted]. Her blindfold was removed and she was asked if she knew who the man in front of her was and she could not identify Mr. [redacted]. Mr. [redacted] stated he gathers intelligence on insurgents for the U.S. and is not present for interviews/interrogations. Mr. [redacted] related this family has posted a wanted poster for his death and has attempted to assassinate him twice and he is currently living in the U.S. complex for security. Mr. [redacted] related he has never assaulted the individuals and has never interrogated the individuals. Mr. [redacted] has been working for U.S. forces as an informant since May 03.

Agent's Comment: Mr. [redacted] will provide a written statement of his own and a translated statement of Mr. [redacted] as soon as possible. Agents were unable to obtain the statements at this time due to imminent threat in the area.

About 0945, 6 Jun 04, SA [redacted] interviewed 1LT [redacted] Physician Assistant, CJSODF, who stated she was present during the apprehension of the [redacted] due to the fact females were being apprehended. 1LT [redacted] could not remember the names of the female detainees, but physically screened them and stayed with them during their stay at the Al-Ademeyah Palace. 1LT [redacted] stated she never witnessed them being abused or saw signs of abuse and physically screened them when they were released from Al-Ademeyah Palace. 1LT [redacted] stated she did not complete medical screening forms due to the fact it was not common practice then. 1LT [redacted] further stated she was outside the interrogation room during the female interrogations and the interrogator was a U.S. soldier and not an Iraqi national.

About 1457, 11 Jun 04, SA [redacted] interviewed Mr. [redacted] Interpreter, Titan Corporation, BIAP, who provided a Sworn Statement wherein he detailed his knowledge of the [redacted] family and related he was at the Ademeya Palace when the alleged incident took place. (See statement for details)

I arrived at Abu Ghraib in mid December. I was assigned as a screener, but for four weeks, I worked in the Hard site with interrogators. When I first arrived, we were told we needed to report any abuse and that if we did not report it, we were just as guilty. The CHIEF took us around the area and gave us a tour of the facilities. In reference to any detainee abuse, I know the following. I heard that a soldier took a female detainee and took her shirt off. The linguist did not report it and they both got charged. I never witnessed the use of dogs during interrogations nor did I witness any detainee abuse. I did not witness any detainees wearing women underwear. One day during a screening, one of the detainees was stripped of all his clothes. The detainee was in one of the rooms. For about 15 minutes, no one touched him. There was a MP female who worked during the in-processing of detainees. The female would hit the detainee on his legs to make him open his legs. She would first hit his left leg and then his right until he fell down. He was then pulled up and pushed to the wall. The MPs were rough and having a female search a male is not right because that is against their religion. There were many detainees who came in abuse. While we were screening the detainees, they would ask us, "Are they going to beat us here too?" In the medical facility, they would start talking. Some would have broken shoulders, others came in on crutches. They do not know who beat them. They said they were beat at ASAMIYA PALACE. The detainees said that even the linguist beat them. They didn't know if Americans were involved. They were abused with cigarette burns, and electric shocks. The doctor documented the bruises. I would say there were about 90 incident that took place in ASAMIYA PALACE. Some detainees would say they were beat up by Iraqis ██████████ b7c-4, b6-7. One name was mentioned a lot by detainees. He was accused of bribing people for money and taking revenge on them. One detainee stated that ██████████ would stick bottles up their rectum. The detainee couldn't sit down. This occurred at ASAMIYA PALACE. There was also a detainee who was handicap and was beat up very bad. ██████████ was a BA'ATH Party member who would gather people up. He would arrest the people and turn them over to coalition forces. The Iraqis said that he was killed by the Iraqis and his body was hung. They say they have no more fear of him. A detainee said he was tortured for 7 days at night at the palace. They submitted two sworn statements. I heard this January or February time frame. There was a group that had been taken to the palace. They were two sisters, two brothers, and two uncles. One of the ladies does not want to talk about what happened to her. There was a detainee who said that he was given cold showers and was under sleep management in the isolation area. The MPs were there and they took orders to do it. The doctors didn't do anything. I checked into this and was told that cold showers was not abusive. The new unit that has taken over is much better and more organized. I spoke to every single woman and they said they spoke very highly of the soldiers. They would be taken out to get some sun. They were treated like brothers. even detainees who are leaving say there were not abused here.

I arrived to Abu Ghraib on 5 December 2003. I have never witnessed and physical abuse in Abu Ghraib. I have seen and heard a lot of yelling and screaming during in-processing. The detainees are yelled at to move faster. These were the MPs not the interrogators. I have never observed dogs being used to threaten a detainee. I never heard any MI tell any MP to "soften-up" a detainee. I never witnesses or heard of any detainee being humiliated or made to wear any women underwear. What I know is what [REDACTED] has told me. There were two sisters [REDACTED] and I do not remember the sister. One of the ladies told me that they had been taken to Al Azimiyah Palace. She said that [REDACTED] an Iraqi Police captured her. He would beat them up and threaten them with their children. [REDACTED] sexually abused the other younger brother who is handicapped. He could not sit and was bleeding from the rectum. The boy was crying because he was sexually abuse with a stick up his rectum. [REDACTED] took her older brother outside and beat him until he passed out. They brought him naked and threw him at me. They said he was dead. [REDACTED] send a message with those captured that he was going to clean up Iraq. [REDACTED] was an Iraqi officer who was promoted for doing a good job. There was one detainee who said [REDACTED] got him and told him that if he wanted to see his wife and children, he had to pay some money to him. His wife delivered the money but he never saw her. One interpreter [REDACTED] was present when he was naked and given a cold shower. He was placed on sleep patterns and was forced to be naked. He did not remember receiving any training. The training we received was nothing in the classroom environment. I felt confident on information we received on dealing with detainees. We didn't get any information on what was acceptable and not acceptable until later on when I was there for a while. In January we finally got a policy. I basically have two individuals I report to. On the administrative [REDACTED] (CACI) is my immediate supervisor and in the military side it is [REDACTED].

[redacted] would like to make the following statement pertaining to the investigation of detainee abuse at Abu Ghraib Prison.

I personally have not seen any detainee abused by anyone where I work, the screening section but have seen detainee's brought to our section that have been abused at other locations. Once our section sees or hears of such actions we immediately report that to our supervisor [redacted] and take the detainee to the Aid Station to report incident.

In late December 2003 or early Jan. 2004 I received a packet on 2 males that were supposedly connected to Fedayeen through their sister [redacted]. Once I received their packet I was to fill out a screening sheet with the detainee and determine whether they had any type of Intelligence Value.

I picked up the first detainee and brought him to the screening room where the detainee was very upset emotionally and shaking begging me not to harm him that he would admit to anything I wanted him to. I don't remember the detainees name but know that he was one of [redacted] 2 brothers. [redacted] I would screen a few days I later. The interpreter, [redacted] tried to calm him down before conducting the screening. The detainee started telling us how he and his other brothers and sisters went to "The Palace" to turn themselves in because they were wanted for questioning by C.F. Once they got there they were detained and were tortured by an ex-I.P. by the name of [redacted] who was working with the C.F. at the palace. He stated that while being questioned, [redacted] would beat him and at one point he actually raped him with a bottle trying to get him to confess to supporting Fedayeen. The detainee also stated that his one brother was beaten to death. I immediately went and reported to my supervisor [redacted] what I was being told. We took the detainee to the Aid Station to have detainee checked out and continued to record everything he told us. We wrote information on the screening sheet and sent the screening sheet to higher command. I have attached the screening sheets I obtained while screening [redacted] and [redacted] on 4 Jan. 2004.

I don't recall which of the detainee's made the following statements but I do recall while asking the detainee's if there were Americans present while they were being beaten one of the males stated that he saw a tattoo of an American Flag on one mans arm and one of the other detainee's stated that they saw a "black man" present while they were being beaten.

While talking to [redacted] she mentioned that her one brother was beaten to death and when I asked her how she knew he was beaten to death she said they brought him into her cell and threw him on top of her. She stated that she knew by the way he felt that he was dead. Detainee's stated that he, [redacted], would threaten to beat them or threaten to have them placed in Coalition Forces custody if they wouldn't give him money.

This incident was the first time that I heard of [redacted] but we have heard the name [redacted] on several occasions from other detainee's I have made the following statement to the best of my knowledge do to the time that has past since the screenings that I took. I would like to further state that when ever I was told of any possible allegations of abuse I would immediately report it to my supervisor [redacted] and record all information given to me on screening sheet that was forwarded to the higher [redacted]

On Dec 22, 2003, my brother [REDACTED] was arrested among more than fifty persons while they were eating in Aladhameya area. and on Dec.23, 2003 they came to our residence. I mean my home resided in Aljamaa and they inspected my home and my company (Ashtar Co. for commercial agencies) which is near by my home. The doors and the furniture were broken at 4:00 at the morning and they did not find anything in my home, and at morning of Dec.24, 2003, I went to the American forces to inquire about my brother [REDACTED] and the reasons of my home's inspection which is not in Aladhameya. because I live in Aljamaa neighborhood. and they told me to bring the rest of my brothers and come at 3:00 after noon, and I went back and brought my brothers [REDACTED] and [REDACTED] according to the appointment and they said that they would interrogate them for a short time. an they asked me to come at 7:00 PM and after I took my dinner I went at 7.00 PM, and I was interrogated by one of the American individuals I don't know his name. After ten minutes of my interrogation I was arrested in Aladhameya Palace and my hands were tied and I was hooded and sit on a wooden chair. and after almost two hours they brought my sister and I heard her crying and we stayed on the chairs until the second day, and at the third day. at 12: 00 at noon they took us to the interrogation place in the Palace hooded and hand tied. and they took off our shoes and stand us against the wall for seven hours During that period I was inspected from the guy named [REDACTED] almost seven times in an attracting attention and impudent way. During that period I heard many sounds screaming loudly, and I tried to remove the cover off my head and I saw a group of kids, and my brother [REDACTED] was one of them and they tried to insert a bottle in their rectum. then I fainted. and the American guy came and carried me towards the wall then I was taken for interrogation by [REDACTED] and Iraqi person his name is [REDACTED] and I was entered in a room. There was an American person, who I met at he beginning, and he told me that he is a judge or the Military ruler here and he has the authority to do any thing against us. and he didn't allow me to talk and then, [REDACTED] told me that my brothers hit the Americans and that I gave them money I said to him that I am not a member in the government or Baath party, so he hit me on my face twice, then he brought witnesses I do not know any one of them except a person who is called [REDACTED] and one of his assistants to witness that I gave money to my brothers to hit the Americans. and I tried to defend myself. so the Military ruler said that I don't have the right to talk and he slapped me on my face twice and I was taken back to the room again with my sister. At night they threw my brother [REDACTED] who looked like dead, and he was bleeding from his hands and legs and he was naked, and his shirt was up and his pants was down, and after a while, the Americans took him and we did not know where did they take him. At the morning of the third day they took us in a bus (18) passengers and they said you will be poisoned in that bus. and we stayed for more than three days. and we did not identify the day and the night. All the kinds of physiological and physical torture were practiced against us. They turned up loud stereos and frightful music and they were banging the bus with a stick, and they did not allowed us to sleep. and when I asked them to go to the bathroom, one of the American persons tied my hands which resulted in dislocated shoulder. All the time we stayed in the Palace. they did not allowed us to eat. After these precautions, they transferred us to Police Academy. and after seven days, they transferred us to Abu Ghrayb prison on Jan.4, 2004

Respected gentlemen
I want to bring to your attention about that issue. The Iraqi people were happy when the Americans came to Iraq and we enjoyed our freedom, as the corrupted regime of Saddam was crushed. but those who were the followers of the tyrant and they are the Iraqi police pretended to act as friends of US forces. These old groups, who were grown up on looting as a result of corruption stayed more than forty years. These groups sold their consciences and made a gap between the Iraqi people and the Coalition forces. My problem and the killing of my brother and all the injures which occurred as a result of a Police man who tried to blackmail us. and when we refused to be blackmailed because we are now in a new era he brought us to what

happened to us now. [redacted] b7C-3, b6-3 tried for several time to blackmail our family, and he knows that we are merchants and not politicians, and he demanded US\$10,000 or we will face horrible results, and virtually that's what happened I am here ready to take all responsibilities if It is proved that I have any relation regarding the attacks against the Coalition forces. I appeal that you give me my rights, an i don't ask for any physical compensation, and all what I need is to give me moral obligation, and bring the killer to justice, and accept my thanks and appreciation and thus the justice would take its place. Thank you.
Even the person, who works with [redacted] b7C-3, b6-2 is the translator [redacted] b7C-3, b6-2 with [redacted] b7C-3, b6-2 with the Iraqi translator [redacted] b7C-3, b6-2

Note. Those who witnessed against me have been informed by [redacted] b7C-3, b6-3 that they would be beaten if they talk about him in front of the American Officer in Aladhameya site. [redacted] b7C-3, b6-2 who works with [redacted] b7C-3, b6-2 and [redacted] b7C-3, b6-2 who witnessed and went out, and a person called [redacted] b7C-3, b6-2 who is existing in the Tent and he is ready for witness as he was frightened, and two persons I don't know. By the way, I don't know the men in Aiadhameya area and I have no relation with them, but [redacted] b7C-3, b6-2 promised them to be released if they witness against me, because I proved to the American officer that he demanded from us amount of money and we refused, and thanks.

And I call to witness [redacted] b7C-3, b6-3 the wife of the translator [redacted] b7C-3, b6-3 that [redacted] b7C-3, b6-3 asked for the money through her husband, but the translator refused to do that, and he said: why do [redacted] b7C-3, b6-5 give you that money and you did not do any thing in return? and she has no relation to you, and you try to exploit her. [redacted] b7C-3, b6-3 existing and is ready to witness as she did before in front of the Aladhameya officer, but the Palace officer. I mean the American officer did not accept her testimony because [redacted] b7C-3, b6-3 is the ruler and the lawyer and the gladiator.

In the month of Ramadan was going to the hospital and a person called [REDACTED] b7c-5, b6-3 took him, and I started looking for him in the police stations and I did not found him. We went to a friend a translator and he said that he knows his location and he took me to the old security building which was run by [REDACTED] and its name is Jarly forces, and it is located on the canal in Alakreemat area and before we entered We found our brother in a pick up car and a person was driving and there were a number of men and among them was a porter in Aladhameya market and his name [REDACTED] and he recognized me and the driver, who was [REDACTED] that my brother had nothing against him and we apologize, but my brother was injured in all his body, and we took him to the hospital and He injured him too much. After two days [REDACTED] b7c-5, b6-3 came to us accompanied with American forces and they started searching the house, and they said that they want my brother [REDACTED] and my husband said to them that my brother has a home and he is near us, why didn't you go to his home and why did you release him before two days? [REDACTED] b7c-5, b6-3 took me from my hand to the car sales lot which was ten minutes from our house, and while we were moving on the road, he asked me to give him an amount of money in return of not coming to us again, and he told me to send the money with the translator who came with you and when we arrived the car sales lot the Americans started searching my car and they did not found anything and it was an excuse for him to be with me alone. They left and after a while I did not send the translator to him because the translator refused, and said to me ignore him, he is disreputable, and you have nothing against you. I went to my neighbors and asked them why [REDACTED] b7c-5, b6-3 is not coming to you and he released your sons from the Palace, and they said that they gave him money but he started to blackmail us and I said to them that he asked me for money and they said ignore him, but after a while he came to our house again and he broke our doors and he stole some dollars from our pocket money and they started shooting in our door, and they said who is shooting against us near your house? But no one shot them, and it was an excuse to capture me, and they took me to the old security building at Jarly forces and we went down to a place underground, and [REDACTED] b7c-5, b6-3 asked me if [REDACTED] b7c-5, b6-3 is my sister and I said to him, yes and he said to me where is the money? and your sister is with you I said to him release me and I will send the money to you, he said, I can not do that but I will leave you, and he left me with three police men who started beating me, and I did not why from 1:00 to 5:00 at the morning and at the morning they took me from Jarly to Aladhameya Palace and my hand tied to my back and my eyes blinded, and I was standing until 4:00 PM, and I was not allowed to sit down. An American soldier came and untied me and removed my hood and brought me a chair and started interrogating me about persons I do not know, and he said to me, do you have money and I told him that my husband's salary is little and my children in the college and we have difficulties in paying their school fees, and he said to my that he will see my husband and if these information are true he would release me. At 12:00, they sent me to Jarly forces and I found my husband is waiting me and he took me back home, and I did not get out of my home for a long time, and at Dec 23, 2003, I went out with my husband and two daughters [REDACTED] b7c-5, b6-3 2years old and [REDACTED] b7c-5, b6-3 7 years old, and we went the market through the express road to Alakreemat, where he stopped me and he was pointing his gun towards us, and I was frightened and so were the children, and I stopped and I thought that they were a gang, and I found that they were [REDACTED] b7c-5, b6-3 and the translator and the commander of Jarly forces, and they ordered me to leave the car and they took it from me and the American drove it, and I sat with [REDACTED] b7c-5, b6-3 and the translator and the children, and they went to Jarly with the children [REDACTED] b7c-5, b6-3 said to me: you and your sister deceived me and I would put you behind the sun, and he left me and went. At 10:00 o'clock they told me that we would go to Alse'rah police station to release the children, and that they will take you to Aladhameya Palace and I begged them to drive the daughters to our home but they refused and the kids began to cry and I left them in the hands of the police men, and I went to Aladhameya Palace and I found there [REDACTED] b7c-5, b6-3 and the commander of Jarly

On Dec 24 2003 corresponding to Wednesday. we went to the Palace in Aladhameya with our sister because she told us that the Americans wanted us for an explanation. Virtually me and my sister and my brother entered. and one of the Americans at the gate stopped us and inspected me and told me to stay there and after a short period he hooded me and tied my hands to my back and put me in a vehicle which went for a very little distance. and there was an Iraq translator. who told me that there was a short stair and he put me on the ground and after almost one hour I heard my brother's voice sitting beside me. then the same American person who was at the gate. came and asked me some questions. and once he said to me. you are fedae and other time he said. you are resistant and I said to him: I swore to god I don't know what do you mean: by these questions. then he said to me. if you do not talk I will not help you. I said to him I swore to god. I swore to god. I do not know what do you mean. then he returned me back to the same place then. a person who talks Arabic came and asked me if I smoke cigarettes and I said: yes. then he push all the cigarette in my mouth. and he told me that I would go to a place where they will beat you and do whatever they want with you. I said to him: why? We did not hurt you but he did not talk to me. After several hours they put us in a vehicle and it went for a short distance and they took me with my brother and put us in a place and put our faces against a wall. then a person came and took me to another place near by. and removed my hood and said to me: did you recognize me? and I said: no. he said to me you will know who am I and when he remove my hood I saw a person wearing American uniform and a person wearing olive clothes. and the person who said to me "did You know me said" to me: you are rich. how did you get that wealth? I was surprised by that question and said to him that my brother in law is a rich man and not us and suddenly they hit my head and legs and my nose. and he said to me we have witnesses against you. and I said to him. bring these witnesses but when they went to bring the witnesses this person who is called [redacted] hit me while facing me. and two persons hit me on my back and I did not recognize them. and when they brought the first witness they removed my hood and said to me. do you know that person I said to them: yes he is from the people of our area and I just say hi to him when I see him. and they asked him: what do you know about [redacted] he said to them. while there was a scar of blood on my mouth. that [redacted] used to bring weapons. and I said to him: where do I bring these weapons. but he did not answer. then they drag him from his shirt. and brought another witness and told him to talk about [redacted] he said I heard. and when he said I heard. they hit him and pull him outside. then they brought another person and said to him: what do you know about [redacted] he said to them that [redacted] has a car and he is looking for you oh [redacted] Then [redacted] said to me: you son of a dog. and kicked me and said to me. why you were looking for me. then they kicked me more than ten times. and said to that person: you can go. without hurting him and they were joking with him. They brought another person and they said to him: talk. what do you know about [redacted] this person was looking at me and his eyes were hitting and there was blood on his face and he said: you work against the Americans. and I said to him. I know why did you say that. and I understood that this person wanted to hurt us He took me to another place and said to me. do you want to see your brother [redacted] I said: yes. and my brothers. I hope I did not ask for that. I saw my brother sitting on the floor half naked at the lower part. so I put a cover on his naked part and I wept. because blood was on his feet and his hands and there were some persons behind my brother and they have the same condition and he said to me I would do more than that with you. and he asked me where do you put the money?. I said to him what money?. I swore to god that my brother in law is rich and not me and my brothers and he said: you will see what I am going to do with you. then he said that an American interrogator would come and I would extract from you what I want. and then he took me to another place which I do not know. but I heard some body said that the interrogator would ask you and you answer. and I said to him that I would answer every question. and the god knows that I am truthful in every word I am going to say. it was the day

of hell to me. specially they did not ask me except one question: are you resistant?, I said : no, I swore to god I do not understand what do you mean then they put me on the ground on my back and hit me with a strong solid tool (iron tool) . and they turn me over on the other side and hit me on my kidney from both sides. and I was screaming loudly , and I said : I will say what do you want me to say and they put water in my nose and they strangled me. and the water was between my nose and my mouth. and I woke up to see the torture again. and they ripped off my dignity by force. when they put a solid tool between my thighs . and I was screaming and begging them and said . I will say to you whatever you want me to say, but it was if no use. but that what happened and I was bleeding from inside and my tears in my eyes. They were not satisfied with that. because they started torturing me next day more than what have done before. and my honor brothers I stayed two days or more without food or water to drink because I was tied to my back against a wall and there was a nail fixed in it. and my eyes was closed, and they were hitting me each time they walked beside me. The other torture was through using a material (is called Balayes. it means Gelatin) and they pulled my dick specially the balls . and I swore to god how painful that was. and that was unbearable, and I was medically treated by an American doctor and he was accompanied with another doctor and a translator . and the translator said to me do you want food or water because I was in a bad shape and my pulse was weak. and the doctors said to the translator they have not to beat that person because his pulse is too weak. They did not care. and that person took me to a place where there was a stair and he said to me I will ask you for the last time. where do your sister put the money. and I said : I swore to god I don't know. then he beat me and threw me from that high place, and he said to me while he was putting hi foot on my rear back: I will fuck your sisters in front of you if you did not talk. and my answer to him was that I do not know. and my brothers. there were many persons who had the same torture and more and he was the person who killed my brother and he had some assistants as [redacted] the translator and others. and he is the person who tortured my brother [redacted] too much and tortured my sisters more and more. Me and my friends want medical check and you have their names and that the money is the reason of our existence in that place.

for being an AIF member which was responsible for numerous attacks against CF, making IED's for AIF activity, and offering other support to AIF resistance cells operating from Samarra to western Baghdad. ODA 523 received 4 IED's from a USSF Source that came from [redacted] and [redacted]. [redacted] was PID'd by a Source, and then he was detained by a joint USSF/CF raid on his residence. [redacted] was then brought back to the temporary holding facility previously maintained by ODA 554. An intell hold was requested and granted to hold [redacted]. Upon arriving at the Adhamiyah Palace Compound, a certified US Army SSG conducted an explosives swab test using the Vapor Trace 2 system, tested [redacted] whose results yielded an extremely high level of RDX which is a high explosive found in many munitions, IED's, and improvised rocket systems. I questioned [redacted] on numerous occasions about his involvement with AIF activity. After a few interrogations, [redacted] provided a detailed confession of his as well as other's AIF involvement. At no time was [redacted] ever abused or mistreated in my presence and no interpreters were ever allowed access to detainees without an ODA member present. I feel that [redacted] claims merely serve as an attempt to get out of prison. This effort has consistently been seen in our area of operations by AIF personnel as a "get out of jail free" card.

After bringing them to Charlie Battery we went out to arrest more suspects including [REDACTED] (ambulance driver), after arresting him and on the way back to base, we saw the white Mercedes leaving the base so we stopped the car where we saw a women driver in it and sitting next to her was the handicap man where they called on me that they were released by the captain. After talking to [REDACTED] he offered his help to us by bringing information relating to people who were conducting attacks against American Forces, including there addresses and they way they bring weapons and one of the names he mentions was [REDACTED] who [REDACTED] said was making I.E.D's and sending it to the Fedayeen along with his brothers [REDACTED] and his sister [REDACTED] and that the main main financial supporter was their sister [REDACTED], and when [REDACTED] saw [REDACTED] and his sister [REDACTED] and screaming that this is the person along with [REDACTED] who was released are the ones who are making and placing I.E.D's so we went back to [REDACTED] sister's [REDACTED] House who claimed that her brother has left Baghdad and she doesn't know anything about him. After arresting one of the insurgent who was using an RPG7, we handed him to the American forces where he confessed that the weapons and money are coming to them from the following People: [REDACTED] and that there sister [REDACTED] distributes the weapons in her white Mercedes and that their other sister [REDACTED] was a member of Saddams close circles and she is financing the Fedayeen with money and weapons, other sources from 2/3 has also mentioned the same [REDACTED] name as the source of financing and support for the insurgents. Also some honest people from Azamiyah has mentioned that [REDACTED] and [REDACTED] are also distributing weapons and RPGs to the Fedayeen in Azamiyah. I would like to mention that when [REDACTED] was still detained in Azamiyah Palace, his brother in law [REDACTED] came to Charlie Battery to ask about [REDACTED] and when he knew that [REDACTED] was arrested, he said that the reason behind [REDACTED] arrest is the [REDACTED] family and especially [REDACTED] where he mentioned that she was lending her car to the Fedayeen and he mentioned that she came and visited them many times in their house where she gave [REDACTED] 250,000 Iraqi Dinar for every attack conducted against American forces and she came and visited him in the hospital after he was injured while firing an RPG and he mentioned that [REDACTED] is financing the Fedayeen, after arresting [REDACTED] and while questioning her, she offered me 20,000 American Dollars on top of her car and one of her daughters. Her Sister [REDACTED] also sent a translator by the name of [REDACTED] that works in one of her houses who also used to work with Alpha Battery who told me that [REDACTED] is waiting for me at her house and that she will give me a huge sum of money so i would turn a blind eye on her family but I refused the offer and went to Captain [REDACTED] and told him. Afterwards a coffee shop was raided in Azamiyah by American forces where lots of suspects were arrested who were brought to the Azamiyah Palace where they were questioned by American forces where some of the suspects confessed that the person who is financing the resistance in Azamiyah is [REDACTED] and that her brother [REDACTED] is the one who purchases the weapons and [REDACTED] distributes it while [REDACTED] makes the Explosive, One of the detainees by the name of [REDACTED] has confessed to attacking American forces and that the financier of the resistance is [REDACTED] and her brothers work with her. DETAILS

BASIS FOR INVESTIGATION: On 11 May 04, this office received a Request For Assistance (RFA)(0106-04-CID259) from the 78th Military Police (MP) Detachment (CID), Baghdad International Airport (BIAP), Baghdad, Iraq, to interview Interpreters [redacted] and [redacted] about their knowledge of any detainee abuse involving [redacted] and the shaving of detainee beards and women's panties.

About 1340, 17 May 04, SA [redacted] interviewed Interpreter [redacted] Titan INC, Abu Ghryeb, Iraq (AGI), who provided a sworn statement relating no knowledge of detainee abuse. (See Sworn Statement)

About 0940, 18 May 04, SA [redacted] interviewed Interpreter [redacted] Titan INC, Abu Ghryeb, Iraq (AGI), who provided a sworn statement relating limited knowledge of detainee abuse. (See Sworn Statement)

About 1330, 19 May 04, SA [redacted] with the assistance of Interpreter [redacted] this office interviewed Detainee [redacted] National Detainee Reporting System (NDRS) # [redacted] who detailed several instances of alleged abuse which occurred to him prior to and after his arrival at Baghdad Correctional Confinement Facility (BCCF). He stated he was captured about 15 Dec 03 in the area of Ishaki, Balad, Iraq, by US forces. He remembers the names of [redacted] and [redacted]. He was transported to Samara. He said from the time of his capture until he arrived at Samara, he was not abused. He said when he arrived at the place in Samara; he was put in a room with "stinky stuff" and called a "bad man" by the US Forces. He stayed in this room for 2-3 days and then they put him in a hole in the ground with other detainees for a couple of days. After this, he said several uniformed US soldiers pulled him from the hole and threatened to shoot him. They then took him to a room and sat him on box with wires attached. He felt heat coming from the box and his body was hurting. He remembers an interpreter with a Kurdish slang. They then put bag on his head and dragged him to a vehicle. They took him to a place they referred to as a "septic tank" and left him for a couple of days. Then he was taken to the Police station in Samara. He said he knows this because the interpreter told him. He said at no time did any Iraqi Police abuse him. He said while he was at the police station he was kicked and punched by one US soldier specifically. He does not remember anything about him. He said he was kicked so hard in the groin, he urinated on himself. He was then taken to BCCF and was placed in tent six of the Ganci Holding Area. While in Ganci, he said he was not abused or tortured. After a few days he was transferred to the "hard site". He was hooded and verbally humiliated. He said one person said, "Don't tell me about torture, you haven't seen torture yet." They then stripped him naked and sprayed him with cold water. They then left him and ordered him to wash his clothes. He was taken to his cell still naked. The next day he was hooded and taken to another part of the building. His hood was removed. He said a tall, thin, white male in uniform, with no facial hair and longer blond hair began to interrogate him. He said the interpreter was an average size Iraqi man. He said two more soldiers held him in the chair and pulled his head back. He said he became unconscious. He said he was returned to his cell. The next day he was taken to the bathroom and

a white man in uniform shaved all his hair to include his eyebrows and mustache. He was stripped naked and sprayed with cold water. He said the same tall blond hair man forced him to put on a pair of white women's panties with a red rose. He was then taken to his cell and left for four days without any clothes or blankets. He said he had to sleep on the floor or the iron bars of the bunk. After four days he received an orange jumpsuit. That same night he was tied to his door and a large dog was biting at him and tore his sleeve off his jumpsuit. He said the handler of the dog was a white male in uniform. He said he was given a new jumpsuit and left in his cell for about 20 days without blankets or a mattress. He has lost most feeling in his right side because of sleeping on the iron bars of the bunk. He requested blankets, but the soldier in charge, a black male, refused. A doctor saw him after the 20 days. They then gave him blankets. Then a black man, named [REDACTED], told him he was going to the tents. He was transferred to the tents. While at the tents, the same blond man came to see him and threatened him concerning the length of confinement. When asked if he had been abused since he was transferred to the tents, he said "no".

AGENT'S COMMENT: Detainee ^{b7E-4, b6-4, b7C-5} [REDACTED] is unable to walk, due to partial paralysis on the right side of his body. He was interviewed while lying on a stretcher.

Status: Your RFA has been completed in the attached enclosures. No further investigative activity is anticipated by this office.
