This investigation was initiated subsequent notification by the Office of the Staff Judge Advocate, Bagram Airfield, Afghanistan, APO AE 09354, that during office clean up they discovered a recordable compact disc (CDR) containing images of suspected detainee abuse.

This investigation is being transferred to the 62d MP Det (CID), 3d MP Group CID, USACIDC, Fort Drum, NY, by request of HQ USACIDC for completion as the majority of the suspects are in their Area of Operation (AOR).

About 1000, 24 Jun 04, this office was notified by the Office of the Staff Judge Advocate (SJA), Bagram Airfield, APO AE 09354 (BAF), that a recordable compact disc (CDR) was discovered in the SJA claims office that might contain detainee abuse images.

At 1030, 24 Jun 04, SA [REDACTED] collected one CDR as evidence from SGT [REDACTED], SJA, BAF, statement pertaining to her finding the disc. The evidence was retained on DA Form 4137, Evidence/Property Custody Document (ECPD), DN 0040-04. (See ECPD and Sworn Statement for details)

AGENT'S COMMENT: The disc was not fingerprinted due to numerous persons handling and viewing the images before it was released into this office's custody.

About 1110, 24 Jun 04, SA [REDACTED] reviewed 134 images on the CDR which yielded the following results:

(1) Images 1 019, 1 022, 1 023, 1 027, 1 064, 1 108, depicted personnel holding weapons on hooded and bound unknown local nationals and wrestling with unknown hooded and bound unknown local nationals.

(2) Images 1 025, 1 028, cotto 041, cotto 042, cotto 043, depicted U.S. military personnel acting as detainees and being abused.

(3) Images 345 though 349, 352, 356, and 357 depicted images of blood stains at various locations within an unknown compound.

The pictures were not labeled or named on the file and the pictures did not appear to be related to any particular claim or legal assistance matter. The pictures I reviewed appeared to depict soldiers handling local national personnel, and there were several other pictures of what appeared to be soldiers engaged in some type of hazing activity. MSG [REDACTED] as on his way to the main SJA office, and I requested that he give this unlabeled CD to CPT [REDACTED], Detainee Operations OIC for her review. 7C/b6-1 [REDACTED] stated that the act of pointing a weapon at a bound, blindfolded detainee, who
was unaware of the weapon, does not, by itself constitute a crime and he disagreed with titling
the suspects at this time. MAJ [REDACTED] stated that he needed corroborating
information, obtained during interviews that any additional abuse was conducted.

About 1610, 11 Jul 04, SA [REDACTED] coordinated MAJ [REDACTED] 7C/b6-3
[REDACTED] and discussed the
possibility of War Crimes or Reckless Endangerment being involved. MAJ [REDACTED] 7C/b6-3
stated that at this point, there is not enough information to determine if a crime has been
committed until there is some dialogue that goes along with the specific images. Even the
dealing with the pictures themselves, it would be unauthorized to photograph them and publicly
humiliate them but due to no identity known, there was no public humiliation.

PRELIMINARY INVESTIGATION REVEALED THAT THE DISC CONTAINED
NUMEROUS IMAGES OF PROBABLE DETAINEE ABUSE, IN THAT U.S. SOLDIERS
BRANDISH WEAPONS AT BOUND AND MASKED DETAINEES. SEVERAL OTHER
IMAGES DEPICTED BLOOD STAINS AND A DEAD LOCAL NATIONAL THAT
APPEARED TO HAVE DIED FROM A GUN SHOT WOUND. ONE IMAGE DEPICTED A
PLATOON ROSTER OF THE SOLDIERS AT THE UNKNOWN LOCATION. IT IS
UNKNOWN WHETHER OR NOT THE DEATH WAS COMBAT RELATED OR AS A
RESULT OF FOUL PLAY. IT IS ALSO UNKNOWN WHO HAD POSSESSION OF THE
CDR PRIOR TO SJA PERSONNEL DISCOVERING IT.

A REQUEST FOR ASSISTANCE TO THE FORT DRUM RESIDENT AGENCY IS
PENDING.

IDENTIFICATION OF THE SUBJECT(S) AND VICTIM(S) IS PENDING.

INVESTIGATION CONTINUES BY USACIDC.

7. COMMANDERS ARE REMINDED OF THE PROVISIONS OF AR 600-8-2
PERTAINING TO SUSPENSION OF FAVORABLE PERSONNEL ACTIONS AND AR
380-67 FOR THE SUSPENSION OF SECURITY CLEARANCES OF PERSONS UNDER
INVESTIGATION.
