I, [REDACTED] b7C-4, b6-4, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

I, [REDACTED] b7C-4, b6-4, on 30 Jun 04, I was on guard duty at point 5. I was watching the perimeter, I noticed something moving next to the fence between point 5 and point 6 at around 0300. I radioed to point 6 for a spotlight at the fence. I got no response, as I was watching the fence I notice a detainee running up the berm outside the wire. I grabbed the radio and called in to liberty base of an escape. As I was jumping off the truck I noticed another detainee running up the berm. I yelled "stop" twice and ran up the berm. I stood on top of the berm and looked for the detainees, it was a steep drop and I heard rocks moving, but I couldn't see anything. I stood there and then noticed one of the detainees running up the other side of the berm. I fired one shot <sup>at</sup> and the detainee and he kept running. I fired another shot and the detainee dropped to the road. I stood there looking for the other detainee. I noticed the other detainee running up the berm. I fired twice, but the detainee ran into the weeds. I ran back down to the camp and called for a flashlight. I got a flashlight and ran back to the berm, down the other side and to the road. By the time I got to the road a hummer stopped in the road and a soldier got out and stood by the detainee on the road. Other soldiers started to come out of the buildings across the street and came to the scene. An SF soldier started doing CPR and tending to the wounds of the detainee. Once the scene was secure I went back to my point and our 1SG [REDACTED] b7C-3, b6-3 was there and

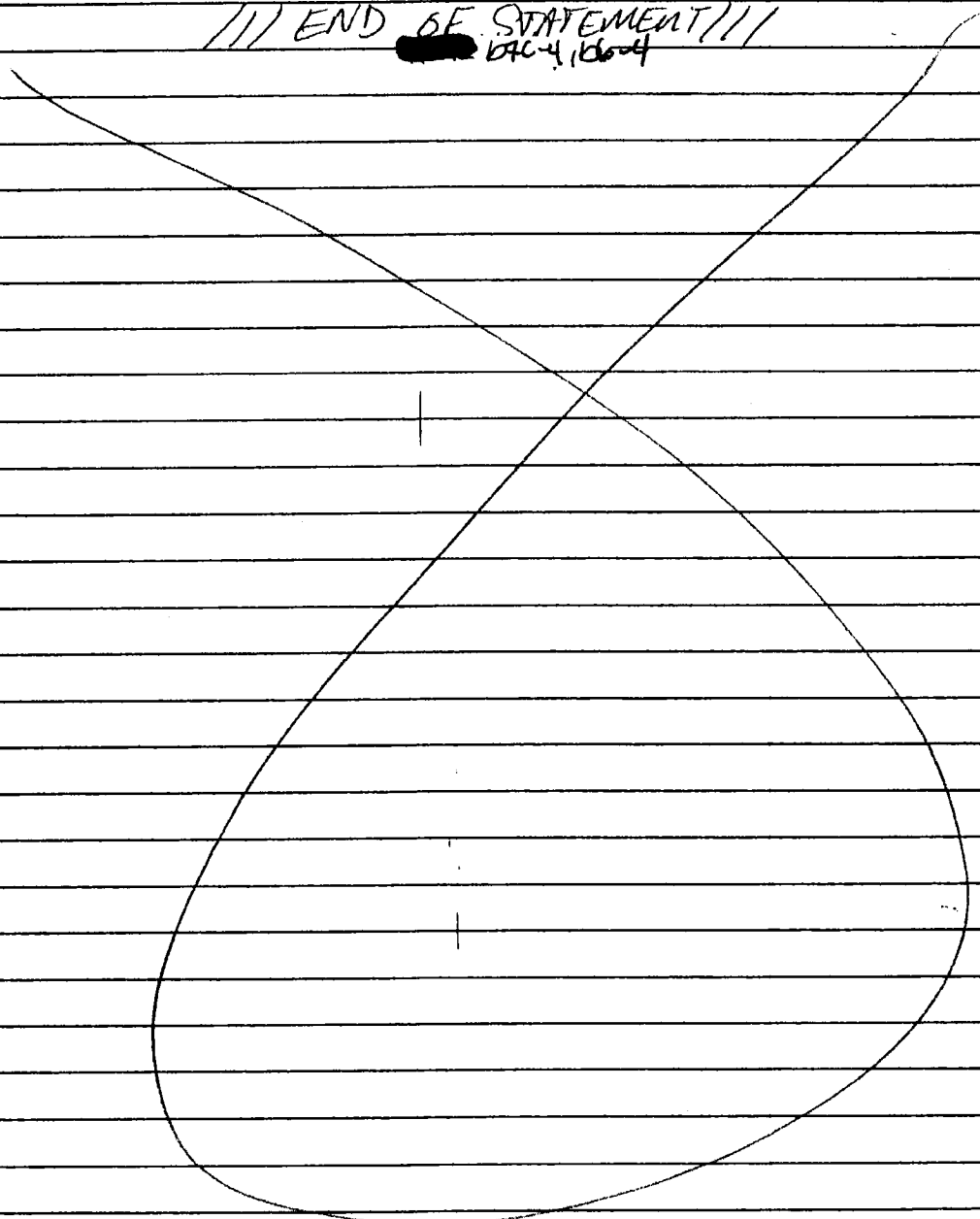

They were observed running away from the detainee area by SPC [REDACTED] <sup>b7c-5,bb-5</sup> 186<sup>th</sup> MP Co, who was on exterior guard duty. He fired a total of four rounds at the two escapees, striking one twice (once in the back and once in the legs). The escapee (Ajkel Abedal Hussein Jabar, #7166) died from his wounds.

According to ACI2 and all available records no formal CID ROI was initiated to investigate the incident.
