

ON 27 MAY 2004, THE  $22^{\frac{10}{10}}$  MP BN WAS NOTIFIED OF THE DEATH OF  $b(a)^{\gamma}$  A DETAINER IDENTIFIED ONLY BY THE NUMBER (MR. SUDHAIL),  $b(a)^{\gamma}$  BY THE MORTUARY AFFAIRS COLLECTION POINT, BAGHDAD INTERNATIONAL AIRPORT (BIAP), IRAQ.

INVESTIGATION ESTABLISHED ON 29 APRIL 2004, MR. SUDHAIL WAS INVOLVED IN AN ATTACK AGAINST ELEMENTS OF THE 1<sup>ST</sup> MARINE EXPEDITIONARY FORCE, IN THE FALLUJAH, IRAQ AREA AND WAS WOUNDED DURING THE ATTACK. HE WAS SUBSEQUENTLY EVACUATED TO THE MEDICAL TREATMENT FACILITY LOCATED AT THE BAGHDAD CENTRAL CONFINEMENT FACILITY, ABU GHRAIB, IRAQ FOR TREATMENT.

ON 21 MAY 2004, MR. SUDHAIL WAS TRANSFERRED TO THE 31<sup>ST</sup> CSH, WHERE HE SUBSEQUENTLY DIED ON 24 MAY 04. MR. SUDHAIL WAS PRONOUNCED DEAD BY DR. (CPT) (NFI). h(2)3 h(7)(6)3

ARMED FORCES
INSTITUTE OF PATHOLOGY, ROCKVILLE, MD CONDUCTED AN AUTOPSY
OF MR. SUDHAIL'S REMAINS, AND DETERMINED THE CAUSE OF DEATH
WAS PERITONITIS AS A CONSEQUENCE OF A GUNSHOT WOUND TO THE
ABDOMEN.
