b-1 Investigation established that the offenses of Cruelty and Maltreatment; and Threatening Communications did not occur as alleged by b-1 b7c4 b6-4 reportedly heard about the incident through rumor. He declined to provide a sworn statement to support his allegations. b-1 b7c4 b6 claimed that the guard urinated in a bottle then gave it to the detainee to drink. This information could not be corroborated by testimony.

( ) Investigation disclosed that PV2 [REDACTED] did act unprofessionally in the performance of his guard duties by yelling at Mr. [REDACTED] unnecessarily; however, his actions were viewed not to be criminal in nature. Consequently, PV2 [REDACTED] did not commit any criminal offense and the offenses of Cruelty and Maltreatment; and Threatening Communications are unfounded. b(6)5 b(7)(C)5

(U) PV2 [REDACTED] received written counseling and corrective training from his chain of command. Subsequent investigation, disclosed no systemic incidents of detainee abuse concerning the guard force.

## DETAILS

( ) **BASIS FOR INVESTIGATION:** On 22 May 2004, the 78<sup>th</sup> Military Police Detachment (CID) (FWD), Baghdad, IRAQ APO AE 09342, notified this office of an allegation of detainee abuse occurring at the b-1, Camp NAMA, Baghdad International Airport (BIAP), Baghdad, Iraq APO AE 09342.

(U) Mr. b-1 b7c-4 b6-4, Debriefing/Interrogator, Joint Interrogation Debriefing Interrogation Center (JDIC), b-1, Iraq Survey Group (ISG), Baghdad, Iraq, APO AE 09342., reported that while he was assigned to the b-1, a guard was reprimanded and assigned to desk duty because he (the guard) urinated in a water bottle and gave it to the detainee to drink.

(U) **Agent's Comments:** It should be noted that b-1 b7c-4 b6-4 was assigned to the b-1 between 6 April 2004 and 23 April 2004. The b-1 leadership suspended b-1 b7c-4 b6-4 for poor performance, explaining that he was ineffective as an interrogator. There were indicators that may have had an ulterior motive for making the complaint.

1.1 Mr. b(6)4 b(7)(c)4 : On 21 May 2004, SA [REDACTED] and SA [REDACTED] 78<sup>th</sup> MP Detachment (CID), Baghdad, Iraq, APO AE 09342, interviewed Mr. [REDACTED] and obtained a prepared statement (Exhibit 2), dated 8 May 2004. Agents [REDACTED] and [REDACTED] documented their contact with Mr. b-1 b7c-4 in an Agent's Investigation Report (Exhibit 3). Mr. b-1 b7c-4 related that he was reporting the conduct because he felt the actions were inhumane even though the J2-b-1 and the medical personnel approved the interrogation prior to execution. Mr. b-1 b7c-4 b6-4 reported he did not witness the "urine drinking" incident but heard about it from the b-1 NCOIC, identified as b-1 b7c-4 in his prepared statement. b64

## DETAILS

(U) Agent's Comments: According to agents [REDACTED] and [REDACTED], Mr. b-1 refused to be sworn to his prepared statement.

(b-1 b7C-4 b6-4) The name b-1 b7C-4 b6-4 as mentioned during the interview of Mr. b-1 was further identified as b-1 b7C-4 b6-4 TF b-1 Camp NAMA, Baghdad, Iraq APO AE 09342.

## 2. (U) INTERVIEW OF SUBJECT:

2.1 ( ) PV2 [REDACTED] HHS/1-21FA, 1st Calvary Division, (TF b-1 Camp NAMA), Baghdad, Iraq APO AE 09342: SA

(b-1 b7C-1 b6-4) identified PV2 [REDACTED] as the guard mentioned in Mr. b-1 b7C-4 b6-4 statement. On 29 May 2004, SA b-1 b7C-1 b6-4 advised PV2 [REDACTED] of his legal rights for aggravated assault, which he waived and provided a prepared statement, dated 21 April 2004 (Exhibits 4 and 5). PV2 [REDACTED] said he became agitated at detainee Mr. [REDACTED] when he discovered that Mr. [REDACTED] urinated in a water bottle within in the confines of the holding cell which violated facility rules. PV2 [REDACTED] denied that he forced Mr. [REDACTED] to drink the urine, however, he did hold the bottle near Mr. [REDACTED] nose. PV2 [REDACTED] related he put the bottle near Mr. [REDACTED] nose in an effort to insure Mr. [REDACTED] knew this was unacceptable behavior.

3.1 ( ) b-1 b7C-4 b6-4 Mr. [REDACTED], National Identification [REDACTED] Baghdad Correctional Confinement Facility (BCCF), Baghdad, Iraq: On 9 June 2004, SA [REDACTED], Prisoner Interrogation Team (PIT) (CID), BCCF, Abu Ghruyeb 09342, responded to a request for assistance, dated 30 May 2004, from TF b-1 CID to locate and interview Mr. [REDACTED]. SA [REDACTED] discovered that Mr. [REDACTED] had been released from the BCCF on 6 June 2004, therefore, was unable to obtain corroborative information to substantiate the abuse allegations made by Mr. b-1 b7C-4 b6-4 SA [REDACTED] provided an Agent's Investigative Report (Exhibit 6) and Mr. [REDACTED] dossier (Exhibit 7).

### 4. (U) INTERVIEW OF WITNESSES:

#### 4.1 (b-1)

HHS/1-21FA, 1st Calvary Division, (TF [REDACTED] Camp NAMA), Baghdad, Iraq  
APO AE 09342: At 1700, 19 April 2004, SPC [REDACTED] provided a sworn statement (Exhibit 8) detailing his knowledge of the matter under investigation. SPC [REDACTED] said while conducting security checks with PV2 [REDACTED] they discovered a bottle of urine in cell #4, which housed Mr. [REDACTED]. According to SPC [REDACTED] he observed PV2 [REDACTED] question Mr. [REDACTED] about the presence of urine inside the water bottle. SPC [REDACTED] did not observed PV2 [REDACTED] mistreat or force Mr. [REDACTED] to drink the discovered urine from the bottle.

Agent's Comments: In the statement of SPC [REDACTED] he refers to PV2 [REDACTED] as [REDACTED].

APO AE 09342: At 1250, 21 April 2004, SPC [REDACTED] provided a sworn statement (Exhibit 9) concerning the matter under investigation. According to SPC [REDACTED], PV2 [REDACTED] told him that he "made the detainee (Mr. [REDACTED]) smell the urine" but Mr. [REDACTED] was not forced to drink the urine. SPC [REDACTED] was alarmed when he heard this information from PV2 [REDACTED] and instructed PV2 [REDACTED] never to do anything "crazy" like that again.

## DETAILS

4.4 ( b-1 ) b-1 TF b-1, Camp NAMA, Baghdad, Iraq, APO AE 09342: At 1800, 27 May 2004, SA b-1 b7c-1 b6-1 interviewed b-1 b7c-4 b6-4 concerning his knowledge of the matter under investigation. According to b-1, b7c-4 b6-4 during January 2004, the TF b-1 Commander directed him to formulate Standard Operating Procedures (SOP) and to provide leadership at the b-1. b-1 b7c-4 b6-4 reported that he was the b-1, between 20 Jan 04 and 15 April 04. He believed the allegations outlined by Mr. b-1 were false. b-1 b7c-4 b6-4 opined that Mr. b-1 b7c-4 b6-4 was ineffective as an interrogator because his (Mr. b-1 b7c-4 b6-4) training was in Strategic Debriefing, which is a different skill set from that of an interrogator. Secondly, Mr. b-1 was not working at the b-1 long enough to shape a credible assessment of the inner workings of the facility. b-1 b7c-4 b6-4 returned to the United States prior to Mr. b-1 b7c-4 b6-4 suspension.

( ) Regarding incidents of detainee abuse, b-1 b7c-4 b6-4 stated there were no reported incidents of detainee abuse during the time he had oversight of a guard force comprised of soldiers from HHS /1-21 FA, 1st Calvary Division b-1 b7c-4 b6-4 provided copies of the b-1 Guard Force Standard Operating Procedures and training program (Exhibits 11 and 12).

(U) During March 2004, the Department of the Army Inspector General (IG) Facility Inspection Team inspected the b-1. They opined that the b-1 had the appropriate oversight in place and thorough standard operating procedures. The b-1 was considered as a model facility. b-1 b7c-4 b6-4 related he received an IG coin of excellence on behalf of the facility from The Inspector General (TIG) of the Army.

He provided a sworn statement (Exhibit 13) concerning his knowledge of the incident and the corrective action taken by the PV2 [REDACTED] chain of command. b-1 maintained there was no indication that PV2 [REDACTED] abused or humiliated the

6.3 (U) On 26 July 04, MAJ b1 77C4 b64 , b1 77C4 b64 b1 77C4 b64 USASOC, Fort Bragg, NC 28310, the supporting Staff Judge Advocate was briefed on the circumstances surrounding the incident. MAJ b1 77C4 b64 opined there was not sufficient probable cause to believe that PV2 [REDACTED] committed the listed offenses of Cruelty and Maltreatment; and Threatening Communications. The provided testimonial evidence coupled with the circumstances surrounding the event did not indicate PV2 [REDACTED] committed a criminal offense.

This is to report that I have witnessed a few instances of harsh interrogations and inhumane conducts by some interrogators and guards at the b1 of TF b1 while I was assigned there as a Humint Augmentation Team debriefer from April 6, 2004 to May 1, 2004.

I am reporting these conducts because I feel that these actions were inhumane even though every harsh interrogation were approved by the J2 of the TF and the Medical prior to its execution.

I have witnessed these harsh interrogations thru the monitor in the video room.

a. A b1 detainee b1 b7c4 b64, going through

**Remark:** I arrived at TF b1 Camp Nama, BIAP IZ. on April 6, 2004 and was transferred out on May 1, 2004. I was assigned there as a Humint Augmentation Team Debriefing/Interrogator. After 3 weeks, they transferred me out because I think they thought that I was not an effective interrogator. I did not feel comfortable watching some of those interrogations. It's not that I couldn't, I refused to conduct my interrogations inhumanely, I tried to conduct my interrogations as professionally as I can to respect their rights because they were in custody not in the front line holding guns against me. One time, I walked out to the bunk to locate one interrogator. They were in the middle of breaking a detainee b1 b7c4 b64 It was so dark I almost tripped over and fell down at the entrance of the room. I could only hear groaning loud human noises and shouting by many people. (I think they were beating the shit out of the detainee.) I could not make out who is who in the room so I left.

I, b1 b7c4 b64, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

I assumed duties as TF b1 OIC on 15 APR 04. On or about 21 APR 04, I was conducting PT when I was advised by the b1 SGM, b1 b7c4 b64, that there had been an incident in the cell block and it was alleged that a member of the Guard Force had forced a detainee to drink urine. The SGM advised me that the soldiers involved or who possibly witnessed the incident were preparing sworn statements regarding the incident and the guard in question. At that point, I went to the JOC and advised the TF b1 Commander of the allegations and informed him that an investigation was underway. I was told to come back to the Commander with a recommendation upon completion of the internal investigation. I then immediately returned to the

A review of the aforementioned sworn statements from PV2 [redacted] SPC [redacted] SPC [redacted] and SGT [redacted] indicated that the guard in question, PV2 [redacted] b1, had not forced a detainee to drink urine. He had instead scolded the detainee for urinating in a water bottle instead of asking a guard to escort him to the latrine. During the course of the scolding, [redacted] had stated that he "should" make the detainee drink the bottle of urine as punishment for not following proper procedures and using the latrine. There was no indication that [redacted] abused or humiliated the detainee. The detainee in question was determined to be b1 roster number [redacted] later assigned ISN [redacted]. I advised the Commander of the findings of the investigation and recommended that we, the b1 leadership handle any disciplinary action. The Commander agreed with this recommendation.

Since [redacted] had made the questionable statement regarding forcing a detainee to drink urine, he was counseled by his Team Leader, Platoon Leader and myself, given remedial training and placed on Front Desk duty for a two-week period. He was also directed to be evaluated by the TF Psychologist, which occurred. Upon completion of his remedial training, desk duty and evaluation by the Psycholoist, PV2 [redacted] was returned to normal duty [redacted].

I, b1 b7c4 b64, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On or about 21 April I was approached by SFC (Guard NCOIC) about an incident involving PV2. I was told that there may or may not have been some kind of Detainee abuse. At his time SFC told me the story of PV2 and the Detainee (ISN in cell number 4. SFC informed me that PV2 was suspected of making Detainee drink urine from a bottle that was in the detainee's cell. After hearing the information from SFC I (b1 b7c4 b64 SGM) informed SFC that I needed every soldier involved in the incident to report to the day room. I then printed off some DA 2823 Sworn Statement forms. I then separated the soldiers and had SFC monitor the soldiers as they wrote their sworn statements. While this was going on I informed the b1 OIC b7c4 b64 of the incident. MAJ b1 b7c4 b64 went to the JOC and informed them of the Command element of the possible detainee abuse then returned to the b64. MAJ b1 b7c4 b64 and I then waited until all sworn statements were done and started to read them. After reading the statements, with all the soldiers still waiting in the day room, I informed SFC that he will take all ammunition from PV2 that PV2 is not allowed to handle the Detainee's until further notice. Also PV2 will be escorted around the camp until further notice. I also let SFC know that PV2 needs to be available to talk to psychologist as soon as the psychologist became available. I believe that while I was letting SFC know what PV2 limits were. MAJ b1 b7c4 b64 went over to the JOC and informed the Command of the findings from the sworn statements. MAJ b1 let the Command element know that from the preliminary findings there was no evidence of Detainee abuse. MAJ b1 b7c4 b64 also recommended that we handle it in house and the Command section concurred. After the Psychologist interviewed PV2 he came back with findings of a confused young soldier that took over heard comments out of context. MAJ b1 b7c4 b64 then counseled PV2 with his leadership present LT and SFC corrective training was imposed with supervision by PV2 leadership. At the next shift change, which was at 2400 hrs, I informed the personnel that an incident had happened and that corrective training was being enforced. I did not go into great details about the incident but I explained to the b1 what had happened due to the rumors that I was hearing around the work area.
