( ) BASIS FOR INVESTIGATION: On 22 May 2004, the 78<sup>th</sup> Military Police Detachment (CID) (FWD), Baghdad, IRAQ APO AE 09342, notified this office of an allegation of detainee abuse occurring at the Camp NAMA, Baghdad International Airport (BIAP), Baghdad, Irag APO AE 09342.

(U) Mr. 5-1 57(-4 66-4 Debriefer/Interrogator, Joint Interrogation Debriefing Interrogation Center (JDIC),

, Iraq Survey Group (ISG), Baghdad, Iraq,
APO AE 09342., reported that while he was assigned to the b-1, a
guard was reprimanded and assigned to desk duty because he (the
guard) urinated in a water bottle and gave it to the detainee to
drink.

(U) Agent's Comments: It should be noted that was assigned to the 5-1 between 6 April 2004 and 23 April 2004. The 5-1 leadership suspended 5-1 b7C-4 bfor poor performance, explaining that he was ineffective as an interrogator. There were indicators that may have had an ulterior motive for making the complaint.

This is to report that I have witnessed a few instances of harsh interrogations and inhumane conducts by some interrogators and guards at the h/l of TF b/l while I was assigned there as a Humint Augmentation Team debriefer from April 6, 2004 to May 1, 2004.

I am reporting these conducts because I feel that these actions were inhumane even though every harsh interrogation were approved by the J2 of the TF and the Medical prior to its execution.

I have witnessed these harsh interrogations thru the monitor in the video room.

Remark: I arrived at TF b / Camp Nama, BIAP IZ. on April 6, 2004 and was transferred out on May 1, 2004. I was assigned there as a Humint Augmentation Team Debriefer/Interrogator. After 3 weeks, they transferred me out because I think they thought that I was not an effective interrogator. I did not feel comfortable watching some of those interrogations. It's not that I couldn't, I refused to conduct my interrogations inhumanely, I tried to conduct my interrogations as professionally as I can to respect their rights because they were in custody not in the front line holding guns against me. One time, I walked out to the bunk to locate one interrogator. They were in the middle of breaking a detainee b 1 b 10 b 4 It was so dark I almost tripped over and fell down at the entrance of the room. I could only hear groining loud human noises and shouting by many people. (I think they were beating the shit out of the detainee.) I could not make out who is who in the room so I left.
