I received a written request for a roster of FBI personnel in Iraq (october to December 2003) from Army CID, which is investigating allegations of abuse at Abu Ghraib. The request was delivered by CID's poc who is co-located with our NJTTF group at LX-1. In addition, Army CID states that the information is necessary to facilitate any possible future interviews which may be requested during official hearings. I have requested more information as to the nature of any purported allegations (either of abuse or failure to report same) against FBI personnel, as well as any proposed interviews. I just spoke with CID's poc by phone and am waiting to hear back from her on these questions.
