[redacted] reported to his Tribunal via a written statement an allegation where he claims to be a victim of abuse. He claims to have been mistreated by two FBI agents in Afghanistan who returned to interrogate him at Guantanamo Bay and during the interrogation at GTMO threatened to "torture him more" if he failed to confess.
