(U) ~~(S)~~ The Regime Crimes Liaison Office (RCLO): Rotation 10 began conducting interviews of High Value Detainees (HVD) on 21 October 2004 at Camp Slayer. Detainees were a compellation of high ranking official during Saddam Hussein's regime.
