I think it is unfair to put it all on the lowest level personnel when their bosses were very involved. Also, the tactics used against detainee #63 and others were extreme and I believe put him in the hospital. As my memo stated he seemed to be hallucinating before the tactics were employed and he needed medical and mental health evaluations but was not given either.

I believe that the [redacted] behavior did not get reported up the DOD chain of command other than possibly in the time-line of [redacted]. I believe there are two reasons for this: 1. [redacted] was advocating extreme, demeaning and possibly Torturous behavior by the military teams; and 2. [redacted] between the FBI and the General and [redacted]
