[redacted] compared the CTD submission to the IG request with our FOIA release and found no records that we missed. There was a record from the NY File, one from the Miami file (the ACLU request was HQ only) and several documents of about 30 pages that were out of scope, i.e. after May 25, 2004; I reviewed these documents along with [redacted]. Therefore, the only additional documents that we have discovered are the two emails which initiated this review and they are being processed for release.
