The Department of Justice (DOJ) Office of The Inspector General (OIG) is conducting an investigation to determine the FBI's knowledge of alleged detainee abuse and related issues. To date a number of requests for information have been received and coordinated by the Inspection Division (INSD) and Office of the General Counsel (OGC).

Given the scope and the sensitive nature of this ongoing inquiry, the Director's Office has instructed INSD and OGC to ensure that there is an accounting and uniformity of all material submitted to the DOJ-OIG. In order to accomplish this in an efficient manner, a Special Task Force will now manage the collection, cataloging, copying and transmission of all documents that are responsive to any and all OIG requests regarding this investigation.

Beginning immediately, material -including documents, electronic files, emails, etc. - produced in response to requests by the DOJ-OIG, MUST be sent directly to Unit Chief [redacted] Special Task Force, Room 1B224.
