He replied that "in this room" he agreed with John McCaine's position that torture should be outlawed, but that "out there" he wants "the bad guys to be scared to death that we're going to torture them to make them talk." He does not believe the US should adopt a hard and fast policy. He is proud that we have a rule in the United States that the police cannot torture suspects, that if someone says, "I want a lawyer," then we walk away. But that's different than being on the battlefield and someone who may potentially have knowledge that could result in immediate death of a bunch of people. If John McCaine wants the rule, Gary M.
